At Great Rivers Greenway, every member of our staff and board is focused on one singular goal: "Making the St. Louis region a better place to live." Every decision we make, from the projects we take on to the programming we support must achieve our mission by connecting communities, providing transportation alternatives, promoting good health, preserving nature or promoting economic vitality within the communities we serve.

This year, we opened 6.2 miles of new greenway trails to the public, including a new connection on the Boschert Greenway from New Town to the Katy Trail in St. Charles, the Al Foster Memorial Trail in Wildwood, our new Jefferson Barracks to Pinnacle Trail in South County and two popular additions to the St. Vincent Greenway - one on the University of Missouri - St. Louis Campus and the other through Ruth Porter Mall Park in the West End Neighborhood. In these 6.2 miles, we've connected communities and people, provided new ways for people to commute, created opportunities for connection to nature, and improved the heath and economic vitality of the communities that we've worked within.

Our final ribbon cutting in 2012 was particularly special because it was on one of our most impactful projects - the St. Vincent Greenway trail through Ruth Porter Mall Park. Throughout

this project, we were privileged enough to partner with residents, businesses and local law enforcement and because of these partnerships, we were able to transform a dangerous and largely unused park into a source of pride for the communities it connects. Perhaps this story more than any other demonstrates the power of a greenway. (See page 5 for more.)

In 2012, we also moved forward as a project partner in the CityArchRiver 2015 project. The project will enhance the Gateway Arch grounds and downtown St. Louis. The District's work will be focused on connecting the Riverfront into the our River Ring through safe and separate bike lanes, while also providing universal access to the riverfront for people of all abilities, families with strollers and the elderly. One component of the project will involve raising Leonor K. Sullivan Boulevard to significantly reduce flooding, and increase the number of days the riverfront will be usable for business and recreation each year.

With our focus on these goals as a means to improve the quality of life for the entire region, one of our proudest milestones in 2012 is the \$187,675 we invested in community partners and non-profits through grants, sponsorships and safety programs. The programs that the District supports are working to preserve the environment, clean watersheds, connect people with one another, provide transportation options and to improve the public's health in innovative ways, and these programs are critical to carrying out our mission of making the region a better place to live.

It has been our honor to deliver on the promises we've made, and to focus on making the vision of the people we serve into a reality for the region. For this opportunity, we extend our gratitude and encourage you to become more deeply involved in our projects and greenways in 2013.

### The Power of a Greenway: St. Vincent Greenway at Ruth Porter Mall Park

erhaps the most compelling example of a greenway that is helping to create a safer environment for residents is the segment of the St. Vincent Greenway which extends through the West End Neighborhood and Ruth Porter Mall Park,

-Darlene Green Comptroller, City of St. Louis from Delmar and DeBaliviere north to Wellston, which we opened in October 2012. The 9-block park in the West End neighborhood in the City of St. Louis had fallen victim to crime and deterioration since it was first built in 1968. Knowing that access to well-maintained public parks significantly reduces crime, we worked closely with residents, the City of St. Louis Parks Division staff

and local law enforcement to identify specific improvements which would increase the usability and safety of the park. More than 25 small hills were removed throughout the park

to improve visibility for both trail users and local law enforcement, and new ornamental light fixtures were installed along the trail. Curbs at streets and alleyways were designed to ensure that people of all abilities could use the trail for fitness, recreation, or for commuting to nearby schools, stores and Forest Park.

"The biggest positive about the greenway is the new lighting," said St. Louis Comptroller, Darlene Green, who has lived near the greenway since 2009. "The trail is now a well-lit, paved area that allows people who are walking around after the sun goes down to feel safe along the path."

After several years of planning, the new park and trail opened in 2012, giving the neighborhood a bright future and creating a safe green space for children and neighbors to enjoy. With additions such as public art, a peace pole, a splash pad and pedestrian lighting, the revitalized park has become a welcoming space for neighborhood activity, and a safe place for everyone to enjoy.





### Community Collaboration: Residents Play a Vital Role in District Projects

his is a great plan and an asset for the community," said one resident after reviewing plans to extend Grant's Trail to River des Peres Greenway which were revealed at our public open house in November.

Residents and business owners from the South County region gathered at Grant's Shelter in Jefferson Barracks Park to view and comment on plans to extend one of the region's most popular trails. The plans detailed a new two-mile segment, which would extend

our most popular trail to more than 10 miles in length, and ultimately connect residents of Kirkwood all the way to Lemay. The open house was one of many we hold each year to gather resident feedback on all stages of our projects – from planning to construction – but it marked a milestone for our District, as the first open house where residents had the opportunity to weigh in on proposed plans both in person and online, with feedback and questions streaming in to designers live from Twitter.

Our District was created to carry out the vision of St. Louis area residents, and we feel that involving them in planning and design is critical to every project. Technology has offered us another way to reach a wider audience. We feel it is incumbent upon us that we take advantage of this opportunity to reach those who may not know how our work is affecting them, and to take their thoughts into consideration as we work to improve their community.

### 2012 Great Rivers Greenway Project Highlights

Great Rivers Greenway opened **6.2** miles of new greenway trails to the public, bridging critical connections within the River Ring. These projects included the Boschert Greenway Phase II project in St. Charles, which connected New Town to the Katy Trail; the Al Foster Memorial Trail in Wildwood; the Mississippi River Greenway trail segment that runs from Jefferson Barracks to River City Casino; the Wayne Goode Trail Extension, which is a portion of the St. Vincent Greenway that runs across the University of Missouri - St. Louis campus and connects students and residents with Ferguson; and the St. Vincent Greenway segment that runs through Ruth Porter Mall Park in St. Louis City's West End neighborhood.

The organization broke ground on 5.25 miles of new trail projects that are currently under construction, including trails on the Centennial, River des Peres and St. Vincent Greenways.

The Safe and Accessible Arch and Public Parks Initiative was presented in December to officials in St. Louis City, St. Louis County and St. Charles County for consideration in the upcoming April 2013 election. The legislation would support maintenance and upgrades to local parks and greenways and partially fund the CityArchRiver 2015 project, if passed. In conjunction with CityArchRiver, Great Rivers Greenway also launched a series of public events to get resident feedback on the CityArchRiver 2015 project.

Plans were unveiled to extend Grant's Trail in November to the River des Peres Greenway. The plan ultimately provides more than 15 miles of connectivity between the two greenways.

Great Rivers Greenway partnered with a variety of organizations on projects that stand to promote economic vitality within

the region including participation in the final design of the St. Vincent Greenway alongside the Loop Trolley project on DeBaliviere Avenue in the City of St. Louis, and the development of greenway connections within the campus of life science incubator Cortex.

# The District was awarded a total of \$5.4 million dollars

in Federal Transportation grants, including \$1.4 million for expansion of the on-street Bike St. Louis network and \$4 million for the reconstruction of the Lenore K. Sullivan Blvd. in front of the Gateway Arch.

The Trestle project was formally launched with a public event in June 2012 with more than 450 in attendance. This marked the beginning of the organization's work to rehabilitate the abandoned Iron Horse rail trestle in North St. Louis. The I-70 overpass was repaired and painted to bring new awareness of Great Rivers Greenway and the Trestle. In December, Great Rivers Greenway was recognized for its Trestle project by Next City's "2012 Disruption Index" as an organization doing work to change an American city for the better.

The District promoted healthy living and public parks through an initiative launched in cooperation with the National Parks Service and BJC Health Systems, with health- and nature-focused artwork on buses and bus shelters throughout the region.

# The District invested more than \$187,675 in community

programs to promote clean water, good health, transportation options and safe trails, through grants and sponsorships, including regional ranger programs, Operation Clean Stream, Trailnet's Bike to Work Day, Livewell Ferguson's resident rides and more.
