

# REQUEST FOR QUALIFICATIONS

# **Sole Provider - Great Rivers Greenway Trail Signage Fabricator**

PERIOD OF CONTRACT: October 2019 through December 2022

#### I. INTRODUCTION

Great Rivers Greenway is a regional public agency serving the City of St. Louis, St. Louis County and St. Charles County. Great Rivers Greenway connects the St. Louis region with greenways, making it a vibrant place to live, work, and play.

The agency is operated by a 25 member staff governed by a 12 member board that is appointed by the Executives of St. Louis City, St. Louis County and St. Charles County. Staff members work within three groups to Build, Promote and Sustain the greenways.

The agency is constructing numerous greenway trails and signage for the various projects is a critical component in providing information to the public traveling along the greenways. This Request for Qualifications (RFQ) is to identify qualified signage fabricators for exterior directional, wayfinding and interpretive signage. Working with its signage consultant, Arcturis, the agency is seeking submissions from interested signage fabricators to choose a primary provider for signage.

The District is interested in contracting with a sole provider of trail signage for a three year period until December 2022.

- Installation is not included in this contract. The District or its construction contractor will handle installation but the signage manufacturer will coordinate all aspects of the process up to installation with the District and/or construction contractor. However, the District does ask for interested firms to submit information regarding installation capabilities. The District may choose to use installation services if it is deemed to be in the best interests of the District.
- Award consideration will be based on a two-step process:
  - 1. Prequalification documentation will first be evaluated to determine if a signage fabricator is qualified to successfully fabricate the signs in accordance with the District's signage standards.
  - 2. Signage fabricators who pass the prequalification phase will be short listed and will be notified they are eligible for the unit cost evaluation phase

Participation Goals for the project are 25% Minority Business Enterprise (MBE) and 5% Women Business Enterprise (WBE). Please note that these percentages are goals, not requirements.



Successful Bidder shall be required to comply in all respects with applicable statutory provisions concerning payment of prevailing wages on public works, Section 290.210 through 290.340 R.S. Mo. 1959, as currently amended, and shall pay to all workmen performing work under contract not less than prevailing hour rate of wages as determined by the Department of Labor and Industrial Relations of the State of Missouri.

# V. GENERAL PROVISIONS

Any contract awarded as a result of this RFQ will be awarded without discrimination on race, color, religion, age, sex, sexual orientation, or national origin.

Prospective consultants shall assure Great Rivers Greenway that they will comply with 2010 ADA Standards prohibits discrimination on the basis of disability, as well as all applicable regulations and guidelines issued pursuant to the ADA (42 U.S.C. 12101 et seq.).

#### MINORITY AND WOMEN BUSINESS ENTERPRISE POLICIES

It is the policy of Great Rivers Greenway that minority and women-owned businesses shall have the maximum opportunity to participate in the performance of contracts utilizing taxpayer funds.

MBE/WBE firms included in the respondent's submittal, either as prime consultants or subcontractors, must be certified by one or more of the following agencies on or before the date of the submission of proposals:

- Missouri Division of Purchasing and Materials Management
- City of St. Louis: Disadvantage Business Enterprise Program
- St. Louis Minority Business Council

#### **VI. SELECTION PROCESS**

A review committee will evaluate all responses to this RFQ. From this review, Great Rivers Greenway may select a consultant(s) solely on the basis of submittals, or may additionally identify a short list of individual or team candidates for possible interviews. The committee may contact any or all respondents to clarify submitted information.

Upon selection of a firm, organization, non-profit or combination thereof, Great Rivers Greenway will negotiate a scope of services and other terms and conditions of an agreement with the selected respondent(s). If such negotiations are not successful, Great Rivers Greenway reserves the right to begin negotiations with other respondents. Respondents who are not selected to begin a contract right away may be called upon in future years to do similar work.

Responses to the RFQ will be reviewed on three criteria for performance:

- 1. Previous Project Experience in Trail Wayfinding Signage or Similar Projects
- 2. Sign Sample
- 3. Sample Shop Drawing and Color Proof



# **Important Considerations**

The District reserves the right, at its sole discretion, to:

- Reject any or all submittals when, in its opinion, it is determined to be in the public interest to do so
- Waive minor informalities of a submittal
- Cancel, revise, or extend this solicitation
- Request additional information which the District deems necessary
- Extract, combine, and delete elements of individual submittals of qualifications
- Negotiate jointly or separately with individual firms with respect to any or all elements of this request.

This RFQ does not obligate the District to pay any costs incurred by any respondent in the submission or in making necessary studies or design for the preparation thereof, or for procuring or contracting for the services to be furnished under this request for qualifications. The District will give preference to Missouri firms when all considerations are equal.
