WHY AND/OR HOW:

The Brickline Greenway is a bold and revolutionary proposal to knit the city together in ways that are both beautiful and meaningful. The Brickline Greenway will weave together St. Louis communities—north, south, east, and west—with up to 20 miles of new greenways, paved and accessible paths connecting our city from Fairground Park to Tower Grove, and from Forest Park to the Gateway Arch and beyond. This is an opportunity to catalyze job and population growth and think differently about what makes a place livable, memorable, and equitable, both for people now and for future generations of residents and visitors. The Brickline Greenway is grounded in our region's sense of civic pride and in our sense of what is possible here. The "Making of a Greenway Framework Plan" completed in 2019 provided 26 action strategies for achieving success around design, equity, economic development and governance.

The Greater St. Louis, Inc's ("GSL") STL 2030 Jobs Plan (the "2030 Plan") identifies the Brickline Greenway as one of the most ambitious and inclusive placemaking efforts in the country. Inclusion of this initiative in *the 2030 Plan* underscores its relevance to the 2030 Plan's broader aims of neighborhood revitalization, place keeping, job creation and small business growth.

Both private and federal funding opportunities require evidence of financial benefits that can result from a project of this scale. GSL is willing to oversee and provide \$99,000 in support of an

economic impact analysis of the Brickline Greenway. This analysis would include exploring

the economic and social benefits of greenway construction, residential prope rty values, transportation and safety,

local business spending/investment, the environment and health. GSL does not have all the funding necessary to complete a comprehensive study and is seeking a partnership with GRG to help fund and collaborate with the economic impact analysis. The study will be done by Ernst and Young who is on retainer with GSL. The Core Leadership group for the Brickline Greenway is very supportive of this study as it will assist them in seeking financial support from potential donors.

The staff seeks approval of a cooperation agreement including \$70,000 to match the \$99,000 from GSL for a total cost of \$169,000. It is anticipated that the study will take three months to complete.

WHEREAS, the Metropolitan Park and Recreation District d/b/a The Great Rivers Greenway District (the "District") is a metropolitan park and recreation district authorized under Section 67.1700 to 67.1769 of the Revised Statutes of Missouri, as amended (the "District Act");

WHEREAS, pursuant to the Clean Water, Safe Parks, and Community Trails Initiative ("Proposition C"), the qualified voters of St. Louis County, St. Charles County, and St. Louis City approved the creation of the District;

WHEREAS, the District was formed to undertake the development, operation and maintenance of a public system of interconnecting trails and parks throughout the areas and counties comprising the District (the "District's Mission");

WHEREAS, in furtherance of the District's Mission, and in accordance with the Bylaws of the District, the District adopted "Building the River Ring" as the Regional Plan for the District, and which contains the comprehensive plan of the District, its existing and proposed interconnecting greenway, park and trail projects, and any proposed land acquisitions (the "River Ring Regional Plan");

WHEREAS, the District desires to extend and improve the River Ring in furtherance of the River Ring Regional Plan by partnering with Greater St. Louis, Inc. to help fund and collaborate with the economic impact analysis. (the "Project");

WHEREAS, pursuant to the approval of Proposition C and Section 67.1712.1 of the District Act, the governing bodies of St. Louis County, St. Charles County, and St. Louis City imposed a one-tenth of one cent sales tax for the purpose of funding the creation, operation and maintenance of the District;

WHEREAS, pursuant to the approval of the Safe and Accessible Arch and Public Parks Initiative ("Proposition P") and Section 67.1712.2 of the District Act, the governing bodies of St. Louis City and St. Louis County imposed a three-sixteenths of one cent sales tax for the purpose of funding the operation and maintenance of the portion of the District located within St. Louis City and St. Louis County;

WHEREAS, the 2022 GRG Operating Budget was approved by the District pursuant to Resolution 2021.97(Operating Budget);

WHEREAS, the 2022 GRG Operating Budget included line item Professional Fees for the Project;

WHEREAS, the District desires to authorize the Chief Executive Officer to (i) negotiate and enter into a Cooperation Agreement with Greater St. Louis, Inc; and (ii) take any actions necessary or appropriate to effectuate the same; and

WHEREAS, at a meeting of the Board of Directors of the District (the "Board"), convened at 11:30 am, on April 12, 2022, at the District Offices at 3745 Foundry Way, St. Louis, Missouri, at which was present a quorum of the Board, the Board took the action further described herein.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE METROPOLITAN PARK AND RECREATION DISTRICT D/B/A THE GREAT RIVERS GREENWAY DISTRICT AS FOLLOWS:

- 1. The Board authorizes the Chief Executive Officer to negotiate and enter into a Cooperation Agreement with Greater St. Louis, Inc. in an amount not to exceed \$70,000 for the Project.
- 2. The Board authorizes the Chief Executive Officer or her designees to take such further action, and execute such other documents, certificates and instruments as may be necessary or desirable to carry out and comply with the intent of this Resolution.
- 3. All actions heretofore taken by the officers, agents, and employees of the District related to the transactions contemplated by this Resolution are hereby ratified and confirmed.
- 4. The portions of this Resolution shall be severable. In the event that any portion of this Resolution is found by a court of competent jurisdiction to be invalid, the remaining portions of this Resolution are valid, unless the court finds the valid portions of this Resolution are so essential and inseparably connected with and dependent upon the void portion that it cannot be presumed that the Board would have enacted the valid portions without the invalid ones, or unless the court finds that the valid

portions standing alone are incomplete and are incapable of being executed in accordance with the legislative intent.

WHY AND/OR HOW:

Starting in 2015, Great Rivers Greenway ("GRG") initiated a process to develop a Project Controls System ("PCS") used for planning and delivering GRG's Capital Improvement Program. The PCS consists of internal business processes, a configurable cloud-based project controls software tool known as "Sciforma" or around GRG known as "Dora," which is used extensively by the Build Team. The Sustain Team also uses Dora for major Sustain Capital Projects that are budgeted at \$100,000 or more. Essential to the overall system is a project controls consultant which as been AMPM Consulting LLC ("AMPM") with Kevin Corwin and his team assisting as GRG's Project Management Office ("PMO").

The PMO duties help GRG staff to support a culture of continuous improvement in the delivery of greenway projects and desires to continue its intentional and dedicated efforts towards project management, best practices and improved quality. Over the years, as GRG's projects have become more complex with more potential risks, the importance of tracking costs, budgets, schedules and risks across the Build and Sustain budget project portfolio is critical. This action item covers services during 2022 for AMPM in carrying out various PMO tasks for GRG. The major tasks identified include the following:

• Management of all Sciforma software updates, upgrades and bug fixes. Complete the migration of GRG's Sciforma configuration to the

latest version in order to take advantage of more and faster Sciforma software updates.

- Continue updates to the Build Team's Project Controls Manual for Project Managers and update procedures as needed. This includes coordination with the Civic Engagement Managers and the update to the Engagement Strategy currently underway. AMPM staff will be assisting to configurate Sciforma to incorporate new Engagement processes as well as the Civic Engagement team's project software.
- Coordinate with GRG leadership on budgeting for Build capital projects as part of the Mid-Year Budget Adjustment and the Capital Improvement Budget. Run reports to provide information to leadership. Work with the Chief of Planning and Projects to evaluate project costs and schedules in order to meet Build Department Program Budget.
- Assist in implementing project and organizational metrics derived from the Regional Plan Update. It is anticipated that the project "scorecard" that has been developed previously will be refined resulting in new configurations in Sciforma.
- Expand the support to the Sustain Team in PCS processes and Sciforma configurations as additional Sustain projects are incorporated into the system.
- Participate in individual project check in meetings with the Build Team to evaluate schedule, budget, risks and other project milestones. Attend weekly Build Team Scrum meetings with GRG leadership.
- Expand the Portfolio and Program processes and reporting developed last year as part of the Brickline Greenway Portfolio Management into all GRG Greenway portfolios.
- Update the GRG Construction Boilerplate Documents and Standard Specifications.

The scope and fee for 2022 services is \$175,000 and is within the \$195,000 budget approved by the Board of Directors. Staff has been pleased with the performance of AMPM over the past three years, which has resulted in improved project delivery and enhancement to GRG's practices and tools used in project management.

The Request for Qualifications ("RFQ") that procured AMPM for consultant services was for a three-year period, 2020 through 2022. As this is the third and final year under the RFQ, a new RFQ will be drafted later this year for another three-year period.
