WHY AND/OR HOW:

In January 2021, Great Rivers Greenway (GRG)'s Board of Directors approved Resolution 2021.02 formally adopting the St. Charles

County Greenway Master Plan. During the project's master planning and engagement process, residents identified nine (9) future project areas as the highest priorities for greenway development in the county. Among these, a new greenway corridor linking Dardenne Greenway at St. Charles Community College to the Katy Trail State Park received the greatest amount of community support. This potential greenway corridor generally follows Mid Rivers Mall Drive and Pitman Hill Road with a connection to Veterans Tribute County Park.

GRG, in collaboration with the St. Charles County, City of Cottleville (Cottleville), City of St. Peters (St. Peters), City of Weldon Spring (Weldon Spring) and Missouri Department of Natural Resources (MDNR), recently sought professional design and community engagement services necessary to complete a master plan for the new, unnamed greenway. Four (4) design firms from GRG's 2020-2022 prequalified vendor list were invited to assemble teams, including a community engagement partner, to interview for the project on May 12, 2022. Following the interviews, staff from GRG and the project partners (St. Charles County, Cottleville, St. Peters, Weldon Spring and MDNR) selected the team led by Planning Design Studio, LLC (PDS) for the greenway planning services and Shockey Consulting Services, LLC for community engagement.


PDS's team includes the following subconsultants:

- Thouvenot Wade & Moerchen, Inc. Assist with Data Collection, Utility Coordination, Cost Estimating, Alignment Review, Opportunities and Constraints
- T2 Traffic Assist with Data Collection, Transportation Planning, Cost Estimating, Alignment Review, Opportunities and Constraints
- Quigg Engineering Inc. Assist with Data Collection (Environmental & hydrological), Cost Estimating, Alignment Review, Opportunities and Constraints

Community engagement activities will run concurrently and in collaboration with the planning process. PDS proposes the following tasks to complete the new greenway master Plan:

- Task 1: Discovery including data collection, evaluation of existing conditions, mapping, coordination with stakeholders and advisory groups, and preparation of an existing conditions summary report.
- Task 2: Analysis including identification of opportunities and constraints, formulation of greenway vision and goals and identification of possible greenway alignments.
- Task 3: Alternatives including development and evaluation of alternative greenway alignments; identification of long-term operations and maintenance issues and opportunities for community, economic development and conservation benefits along the greenway; and preliminary cost implications for the various alignments
- Task 4: Refinement including recommended preferred alignment based on evaluation criteria and community and stakeholder feedback, refined cost summary of the preferred alignment, implementation and phasing strategy for greenway development, and supporting documentation such as site plans and renderings
- Task 5: Documentation including production of a final report and executive summary with all greenway recommendations

The 2022 budget for the (364) project includes \$300,000 GRG 1/10 Budget funding. Contract expenditures within 2022 are project to remain within the available budget. The 2023 GRG 1/10 Capital Budget will include the funds for the remaining effort within the contract, subject to Board approval. Therefore, GRG desires to authorize the contract with PDS and utilize funding from both fiscal years 2022 and 2023. PDS's schedule anticipates completion of the master plan by fall of 2023. Future stages of the project will include design, engineering and implementation (construction) of the greenway plan recommendations. Upon successful completion of the Master Plan project, GRG intends to retain the same Design and Community Engagement consultants for future stages of the project.

A RESOLUTION APPROVING A CONTRACT NOT TO EXCEED \$275,000 WITH PLANNING DESIGN STUDIO, LLC. IN CONNECTION WITH PITMAN HILL GREENWAY AND AUTHORIZING OTHER ACTIONS AS NECESSARY TO EFFECTUATE THE SAME.

WHEREAS, the Metropolitan Park and Recreation District d/b/a The Great Rivers Greenway District (the "District") is a metropolitan park and recreation district authorized under Section 67.1700 to 67.1769 of the Revised Statutes of Missouri, as amended (the "District Act");

WHEREAS, pursuant to the Clean Water, Safe Parks, and Community Trails Initiative ("Proposition C"), the qualified voters of St. Louis County, St. Charles County, and St. Louis City approved the creation of the District;

WHEREAS, the District was formed to undertake the development, operation and maintenance of a public system of interconnecting trails and parks throughout the areas and counties comprising the District (the "District's Mission");

WHEREAS, in furtherance of the District's Mission, and in accordance with the Bylaws of the District, the District adopted "Building the River Ring" as the Regional Plan for the District, and which contains the comprehensive plan of the District, its existing and proposed interconnecting greenway, park and trail projects, and any proposed land acquisitions (the "River Ring Regional Plan");

WHEREAS, the Pitman Hill Greenway is shown as a regional greenway in the River Ring Regional Plan (the "Pitman Hill Greenway");

WHEREAS, the District desires to extend and improve the River Ring in furtherance of the River Ring Regional Plan by preparing a greenway master plan (the "Project");

WHEREAS, pursuant to the approval of Proposition C and Section 67.1712.1 of the District Act, the governing bodies of St. Louis County, St. Charles County, and St. Louis City imposed a one-tenth of one cent sales tax for the purpose of funding the creation, operation and maintenance of the District;

WHEREAS, the 2022 GRG 1/10 Capital Budget was approved by the District pursuant to Resolution 2021.98;

WHEREAS, the 2022 GRG 1/10 Capital Budget included line item 364 for the Project;

WHEREAS, the 2023 GRG 1/10 Capital Budget, subject to future appropriations, will include Project funding;

WHEREAS, pursuant to the District's Procurement Policy, the District invited four (4) firms from the 2020-22 Prequalified Vendor List for or in furtherance of the Project and interviewed three (3) consultant teams responses;

WHEREAS, Planning Design Studio, LLC was found to be qualified and whose proposal is in conformance with the requirements of the District Act (the "Proposal");

WHEREAS, the District desires to (i) authorize the Chief Executive Officer to approve and accept the Proposal; (ii) negotiate and enter into a contract with Planning Design Studio, LLC; (iii) fund the Project from 2022 and 2023 GRG 1/10 Capital Budgets, and (iv) take any actions necessary or appropriate to effectuate the same; and

WHEREAS, at a meeting of the Board of Directors of the District (the "Board"), convened at 11:30 am, on July 12, 2022, at the District Offices at 3745 Foundry Way, St. Louis, Missouri, at which was present a quorum of the Board, the Board took the action further described herein.





- Development of Basic Outreach Materials including a project fact sheet, newsletters, website content, project partner newsletter content, and social media pushes.
- Assistance with Greenway Naming Campaign Development of naming engagement process and selection criteria, preparation of engagement materials and public input summary.

- Community Advisory Committee Participant Selection and Support Meetings including meeting scheduling, developing support materials, meeting attendance and meeting notes.
- Technical Advisory Committee Support Meetings including development of invitations.
- Open House Public Meetings including scheduling, invitations, meeting guides, comment form, promotion among project partners, meeting logistics, set up, attendance and meeting documentation.
- Survey development and administration
- Development of Media Packets and outreach to promote public meetings



Of the four (4) invited teams, two (2) of the prime consultant firms declined the Invitations to Interview. The remaining two (2) firms interviewed with Great Rivers Greenway staff and a unanimous decision was made to recommend Lochmueller Group to lead the planning phase engineering services.

WHY AND/OR HOW:

This action requests to authorize the CEO to negotiate and enter into a contract with Lochmueller Group, Inc. (Lochmueller Group) not to exceed \$276,000 in connection with planning phase services for the Maline Greenway: West Florissant Avenue to Bella Fontaine Park West segment.

General Information

In 2010 - 2011, Great Rivers Greenway (GRG) worked in partnership with its consultant, Woolpert, Inc., and various municipalities of north St. Louis County to study the Maline Creek corridor. The study area covered a 1-mile wide area (1/2-mile on each side of the creek) and ran through portions of the cities of Berkeley, Kinloch, Ferguson, Jennings, Moline Acres, Bellefontaine Neighbors, Riverview, and St. Louis, as well as unincorporated St. Louis County. GRG staff worked with a Citizen Advisory Committee and a Technical Advisory Committee to develop the 2011 Maline Greenway Concept Plan, which now serves as the master planning document that identifies the general alignment for the 8-mile long Maline Greenway.

The completed portion of Maline Greenway trail runs 2.12 miles from St. Louis County's Bella Fontaine Park West, eastward through Bella Fontaine Park, and ends at St. Cyr Road near where Maline Creek crosses from Bellefontaine Neighbors into the City of St. Louis. In 2023, GRG will begin constructing a separate 1.6-mile segment between the Ted Jones Trail and West Florissant Avenue in the City of Ferguson. Between these two sections of trail is an approximately 2-mile gap within the Cities of Ferguson, Jennings, and unincorporated St. Louis County. That gap has become project (296) Maline Greenway: West Florissant Avenue to Bella Fontaine Park West.

Project Background

The 2011 Maline Greenway concept plan identified a creekside alignment that would cover this 2-mile gap between West Florissant Avenue and Bella Fontaine Park West. This alignment holds potential to be the future Maline Greenway, but due to site constraints such as flooding, floodplain permitting, and environmental safety, an alternative alignment has also been identified for planning phase analysis (see attached map graphic). Through robust community

engagement and technical engineering scopes of work, GRG staff seeks to identify a final recommended alignment to be developed further in the design phase. Staff now seeks Board approval to initiate a planning phase scope of work with a recommended consultant team.

In May 2022, staff invited four (4) engineering firms from the Board approved Vendors List to interview for this project's planning phase as well as future phases including design, site control, and construction. Each engineering firm was asked to partner with a community engagement vendor and form teams in preparation for the interview. GRG's project manager would manage the contract with the engineer led team, and the Civic Engagement Manager would manage the contract with the community engagement team. After careful review of vendor qualifications, GRG staff delivered the Invitation to Interview to the following four (4) engineering firms:

- -ABNA Engineering, Inc. ("ABNA") MBE, WBE, DBE
- -Engineering Design Source, Inc. ("EDSI") MBE, DBE
- -Lochmueller Group
- -Oates Associates, Inc. ("Oates")

After receipt of the invitations, ABNA declined the invitation. Additionally, EDSI notified staff that it would best serve the project's needs as a subconsultant managed by Lochmueller Group as the prime consultant. As such, the selection committee of GRG staff interviewed the remaining two (2) qualified teams in June 2022. Based on the results of the interviews and each team's respective DEI participation commitments, the selection committee recommended Lochmueller Group as the engineering firm, along with Vector Communications Corporation ("Vector") for community engagement. *For reference, the contract with Vector will be brought before the board via a separate resolution.

Lochmueller Group's team of sub-consultants for the planning phase includes the following firms:

- -EDSI (hydraulic and structural engineering) MBE
- -SWT (landscape architecture)
- -Tsi (geotechnical engineering) WBE

In coordination with GRG's planning phase template scope of work, the proposed scope that comprises the following phases that are expected to be complete in 2023:

- 1. Kick-Off
- 2. Discovery
- 3. Data Analysis
- 4. Generation of Alignment Alternatives
- 5. Refinement of Alignment Alternatives
- 6. Final Report Documentation

For 2022 - 2023 planning phase services, Lochmueller Group has developed a fee proposal for a not to exceed amount of \$276,000. The DEI goals for this project are 25% MBE / 5% WBE, and the proposed scope and fee yields 26.6% MBE / 5.1% WBE participation. The 2022 budget for the (296) project includes \$380,000 in GRG 3/16th funds. Contract expenditures within 2022 are projected to remain within the available budget. The 2023 GRG 3/16 Capital Budget will include the forecasted funds to complete any remaining contract scope, subject to future Board approval. Therefore, GRG desires to authorize the contract with Lochmueller Group and utilize funding from both fiscal years 2022 and 2023.

Staff recommends approval of this contract.


