WHY AND/OR HOW:

During recent contract negotiations, questions regarding State of Missouri statutory requirements surrounding preference for purchasing in Missouri and the United States have arisen. While we have been following State requirements, after researching the issue, we believe that minor modifications to the District's Procurement Policy will strengthen the District's compliance efforts. The changes will reference four (4) statutes addressing purchases. Specifically, RSMo 67.1748, relating to preference for Missouri products purchases, RSMo. 34.353, relating to purchasing U.S. goods, and RSMo. 34.073 and 34.076 relating to potential additional requirements imposed upon out-of-state contractors will be addressed. In addition, we believe that the District's current minority contracting goals should also be included in the Procurement Policy.

Staff requests that the Personnel, Policy and Procedures Committee approve and refer the the Board the revised Procurement Policy.

WHEREAS, the District was formed to undertake the development, operation and maintenance of a public system of interconnecting trails and parks throughout the areas and counties comprising the District (the "District's Mission");

WHEREAS, in furtherance of the District's Mission, and in accordance with the Bylaws of the District, the District adopted "Building the River Ring" as the Regional Plan for the District, and which contains the comprehensive plan of the District, its existing and proposed interconnecting greenway, park and trail projects, and any proposed land acquisitions (the "River Ring Regional Plan");

WHY AND/OR HOW:

As part of the District's DEI Plan as well as the Regional Plan Update, staff has investigated opportunities to diversify a portion of the District's fund balances in a targeted manner. This summer, staff issued an RFQ for Community Impact Banking with the objective of identifying local financial institutions who are actively engaged in elevating the people and businesses in our region, particularly in historically underserved areas, including but not limited to, the 22 zip code footprint serving as the focus area of the St. Louis Anchor Action Network of which the District is a part. Respondents were asked to submit information regarding financial strength, ability to meet District requirements and policies, estimated return on deposits, community impact statements including lending practices, locations within underserved communities and internal DEI practices.

We received six (6) submittals from: Busey Bank, Commerce Bank, Enterprise Bank, Midwest Bank Centre, Regions Bank and St. Louis Community Credit Union. Each of the institutions are actively engaged in these communities and committed to this work. It is important to note that Commerce Bank, with whom we have our primary banking relationship, is included in this group. While we recommend additionally approving Enterprise Bank, Midwest Bank Centre, Regions Bank and St. Louis Community Credit Union as Qualified Community Impact Banking Institutions, staff further recommends that the District's initial investment of funds go to Midwest Bank Centre. See attached summary.

Prior to investing funds, staff will return to the Board with necessary authorizing documentation for each institution with whom we invest funds as well as details regarding amounts and specific investments.

Staff requests Board approval for a Community Impact Banking Pre-Qualified list to include: Enterprise Bank, Midwest Bank Centre, Regions Bank and St. Louis Community Credit Union.

WHY AND/OR HOW:

Construction on project 737x in Deer Creek Park started in 2021 and wrapped up mid-year 2022. This project was undertaken to repair a section of failed streambank and improve drainage issues in the park. The project was completed in cooperation with the City of Maplewood (Maplewood); Maplewood paid for the drainage repairs associated with their adjacent athletic fields and the District paid for the repairs to the streambank. Very shortly after this project was completed, the region experienced historical flooding and Deer Creek Park was one of the greenways significantly impacted. Staff evaluated the project and thankfully, a vast majority of the streambank restoration work was not impacted. Peripheral areas did sustain damage such as lost trees, soil scour and deposits and some erosion along the bank.

DJM Ecological Services, Inc. (DJM) was the subcontractor on the 737x project and was tasked with all of the conservation, landscaping and some of the streambank restoration activities. DJM is also a current contractor for the District, procured in 2020, responsible for conservation and maintenance operation services throughout our greenway system. The repairs necessary to return this area to pre-flood conditions are within the scope of work procured by DJM in 2020 and they are intimately familiar with the project. Staff feel it is in the best interest of the District to utilize the existing contract with DJM to expedite these repairs during the

remaining growing season and deliver a finished project to the City of Maplewood and Greenway users as soon as possible.

District staff and DJM evaluated the necessary repairs and a scope of work was developed. The cost estimate for those repairs is \$81,050. District staff are requesting an additional 10% for contingency for a total of \$89,155. District staff are requesting these repairs be made by DJM through an amendment to their 2022 contract which was for \$80,000. Their new contract amount would be \$169,155. This work is scheduled to be completed in 2022.

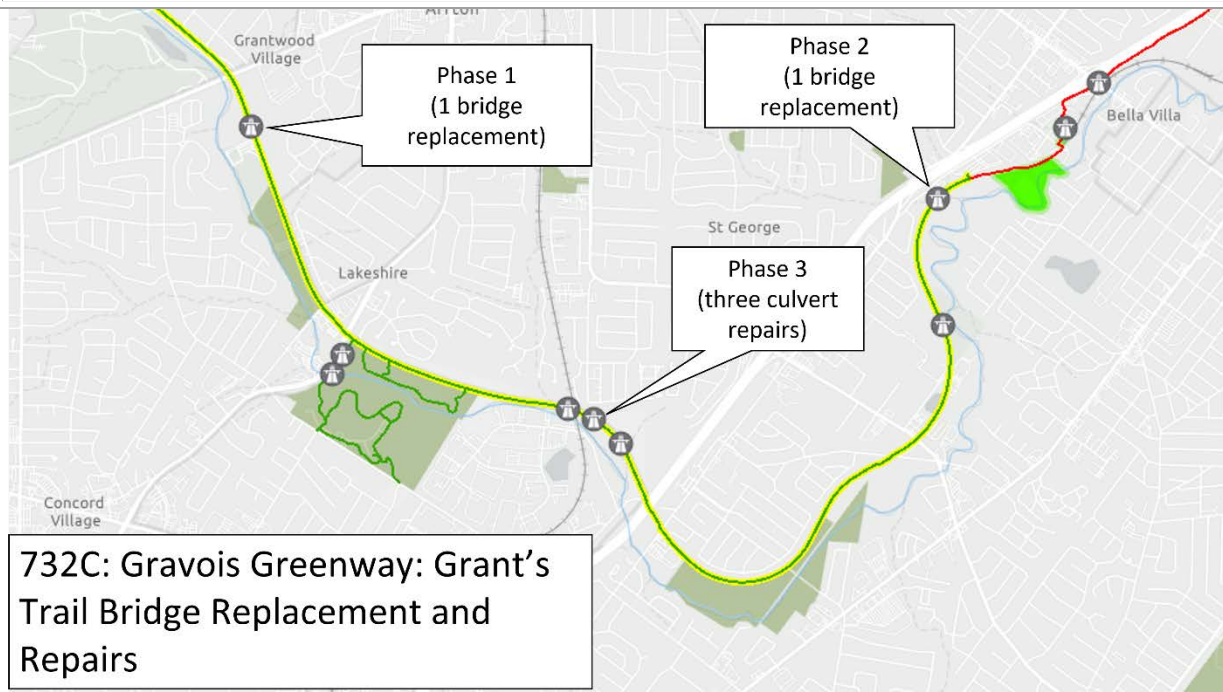
The District contracted with Thouvenot, Wade and Moerchen, Inc. (TWM) to conduct ten (10) bridge inspections along Gravois Greenway in 2020. Inspection reports included recommendations for repairs to three (3) bridges and the replacement of two (2) bridges owned by St. Louis County. The County requested to enter into a cooperation agreement for the District to pay for and administer the design and development of bid documents and the County to pay for and administer the construction of these structures.

District staff entered into a contract with TWM to complete the design and construction documents for the replacement and repairs of the five (5) structures. Construction estimates were higher than St. Louis County (County) was able to undertake in a single fiscal year, therefore the project was separated into two (2) phases. TWM finalized construction documents for Phase 1 and the County advertised for bid. Bids were opened in late 2021 for the replacement of the Dillman Bridge near the Mysun Trailhead and a bridge near the Affton Athletic Association, but bids were much higher than estimates and all parties determined it was best to decline all bids and reevaluate the approach.

St. Louis County determined it would only be feasible to fund these repair/replacements if the project was separated into three (3) fiscal year phases instead of two (2). TWM will need to increase their scope and fee to

develop three (3) bid packages and oversee construction assurance (CA) services for these three (3) projects. Phase 1 is scheduled to be advertised for bid in November 2022, Phase 2 in Spring 2023 and Phase 3 in early 2024. The original contract amount for design and bid documents and CA services in a single phase was \$416,297. The additional fee for three (3) phases of construction is \$41,935 for a total contract of \$458,232.

This action item would authorize the District CEO to negotiate and enter into an amendment to the current contract with TWM for \$41,935 for the development of construction documents for all phases of repairs and provide CA services during the three (3) build phases.

WHY AND/OR HOW:

Construction of the Deer Creek Greenway extension into the City of Brentwood (the "City") began in 2021 as part of the City's massive \$90 million Brentwood Bound initiative. Brentwood Bound is a comprehensive plan to renew the area between Manchester Road, Deer Creek, Brentwood Boulevard and Hanley Road. There are three (3) components to the plan: Deer Creek flood mitigation; improvements to Manchester Road; and an extension of Deer Creek Greenway, from Marshall Avenue north to Rogers Parkway (the Deer Creek Greenway connector project). Great Rivers Greenway ("GRG") staff have been collaborating with the City on the design

and implementation of this project since 2017 and our cooperation has been authorized by a series of GRG Board resolutions, 2017.08, 2018.51, 2019.94 and 2020.78.

The current agreement (per resolution 2020.78) to construct, operate and maintain the Deer Creek Greenway connector committed \$3 million of GRG financial support for the project, subject to annual appropriations of \$1.5 million in 2021 and \$1.5 million in 2022 from GRG's annual budget for project #287 Deer Creek Greenway. At the time this agreement was prepared and executed, both GRG and the City expected that greenway construction would be complete by the end of 2022. However, due to several delays, it has become clear that project construction will not be complete until 2023. These delays have been caused by two (2) major issues: 1.) slower than expected coordination with Union Pacific Railroad to complete upgrades to the rail crossing at Brentwood Boulevard and Russell Avenue, and 2.) multiple unprecedented storm events in late July and early August this summer. While these storms demonstrated the effectiveness of the reconfigured floodplain to minimize impacts to surrounding properties and transportation network, the resulting flooding of Deer Creek caused major disruption to the Brentwood Bound project construction, including significant loss of contractor equipment, newly placed and graded top soil and previously established erosion control material.

As a result of these delays, GRG and the City have proposed amending the existing agreement to extend the terms of the agreement and reimbursement period into 2023. This amendment will not increase GRG's financial obligation to the project above the established \$3 million budget. Substantial completion of the public open space features of Brentwood Bound, including the majority of the Deer Creek Greenway trail, is expected in spring 2023.

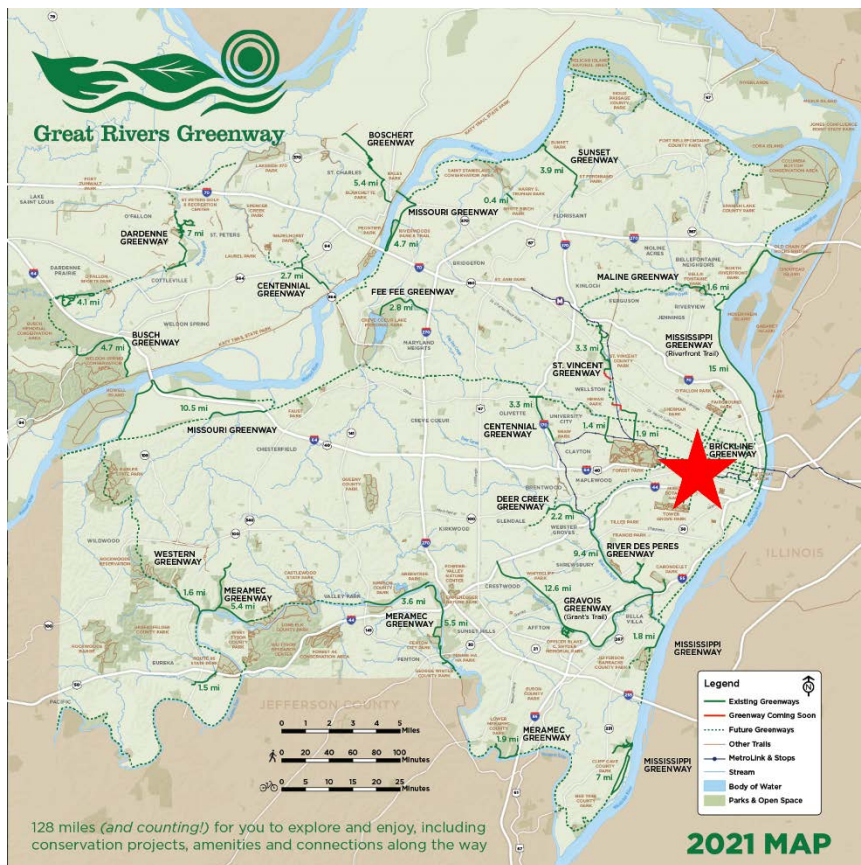

WHY AND/OR HOW:

Great Rivers Greenway (GRG)'s Board of Directors approved the Chouteau (Brickline) Greenway Framework Plan in December 2019. This project is designed to connect Forest Park, Gateway Arch National Park, Fairground Park, and Tower Grove Park with up to 10 miles of urban greenways through many neighborhoods in the heart of St. Louis. In 2020, the Board approved changing the name of the project to Brickline Greenway.

The Brickline Greenway Framework Plan includes a concept for a pedestrian and bicycle crossing of I-64 and the adjacent railway corridor within the Midtown neighborhood of St. Louis. The project lies at the central crossroads of the Brickline Greenway near the City Foundry STL and Armory District developments, Saint Louis University, St Louis University Medical Campus and the Grand Metrolink station (308K), as shown in the map below. Pursuant to Resolution 2021.52, GRG has worked with a consultant team led by EFK Moen, LLC (WBE) to study the feasibility of a bicycle and pedestrian crossing the highway corridor within the project area (identified as the I-64 Area on the map below). As the proposed crossing of I-64 involves the Missouri Department of Transportation (MoDOT) and its interstate Right-of-Way, extensive coordination with MoDOT was completed in the feasibility study. The effort produced a feasible and preferred greenway crossing of I-64 at Spring Ave.

The grant application includes the Rail Study Area which extends from the Grand Metrolink Station and the various railroad lines to Chouteau Avenue and the edge of the St. Louis University Medical Campus.

This Board Resolution will enable Great Rivers Greenway to submit an application to the U. S. Department of Transportation (USDOT) for a Reconnecting Communities Pilot (RCP) Discretionary Grant Program for a planning grant. The competitive RCP grant will fund \$50 million in planning projects throughout the country with a maximum award of \$2 million for each awarded project. A minimum 20% local match of the total project cost is required.

The total planning project cost for this segment of the greenway is estimated to be \$2.53 million. The application seeks \$1,988,000 in federal funding (79% of total project cost). Matching funds total \$542,000 (21% of total project cost) and come from two sources: GRG local matching funds are \$263,000 and private donation funds are \$279,000. The scope items included in the proposed planning grant include: community engagement, data collection, agency/stakeholder coordination, preliminary design (I-64 Study Area) and alternative analysis and rail crossing feasibility study (Rail Study Area).

Applications are due on October 13th. It is anticipated that applicants will be notified in Spring 2023 on the status of their applications.

This action requests to authorize the CEO to negotiate and enter into a contract with Ahrens Contracting, Inc. in an amount not to exceed \$579,565, including a 10% contingency, for the demolition and site restoration of 701 North Leonor K. Sullivan Boulevard (402B Mississippi Greenway: North Riverfront Garage) in the City of St. Louis, MO (City).

In November 2021, through a partnership between Great Rivers Greenway (GRG), Advantes Group and Land Clearance for Redevelopment Authority (LCRA), GRG was able to acquire the shuttered old North River Front Parking

Garage structure located at 701-713 North Leonor K. Sullivan Boulevard (Wharf Street), St. Louis, MO 63102, as approved by GRG Board Resolutions 2021.72C.

The garage is a 4-story, +/-30,000 sq. ft., pre-cast concrete structure which is located within the City Wharf Line, on the eastern side of Laclede Landing and within the FEMA Regulatory Floodway for the Mississippi River. The structure is immediately adjacent to a very active railway trestle which is owned and operated by Terminal Railroad Association of St. Louis (TRRA).

In March 2022, GRG issued a Request for Proposals (RFP) for Pre-Construction & Construction Management Services related to the demolition and decommissioning of all infrastructure, equipment, asphalt and concrete present on the property. This also includes overseeing the decommissioning of all subsurface utilities present on the subject site, as required by the City. Per GRG Resolution 2022.33 Kozney Wagner, Inc. (KWI) was contracted for the pre-construction and construction management services to coordinate the demolition of the parking garage. KWI drafted a plan including hiring a design consultant to complete construction documents, coordination with the City, TRRA and other required governmental agencies/bodies.

ABNA Engineering, Inc. (ABNA) was selected by GRG staff and approved by GRG Resolution 2022.34 for the completion of 100% Final Design construction documents. Given the constrained site conditions, the demolition of the garage will remove the upper levels of the parking garage but leave the concrete retaining walls on the western edge of the property. The site will have clean fill brought in to cover the remaining retaining walls which will match the existing grades of the adjacent streets. Grass will be installed and GRG staff has included an irrigation system in the bid documents to ensure the grass remains healthy during dry periods.

Following completion of 100% Final Design construction documents, the project was advertised locally via the St. Louis American and the St. Louis Post Dispatch. Additionally, it was posted to the GRG website with notifications to GRG's bid notification email distribution list and Bid Express on August 25, 2022. An on-site pre-bid meeting was hosted by GRG staff with the assistance of KWI and ABNA on September 01, 2022.

Four (4) bids were received by the solicitation deadline of September 15, 2022 at 3:00pm. Details on the four (4) bids are noted above and staff and

our construction management team were pleased with the four (4) bids submitted considering the scope and scale of the project.

Staff from KWI and ABNA reviewed the bid tabulations and submitted materials to ensure compliance with bid requirements. Bid day results and subcontractor details, including participation of minority and women-owned businesses, were analyzed. The low bid, submitted by Ahrens Contracting, Inc., met the project's diversity inclusion goals of 25% MBE and 5% WBE by submitting 25% MBE and 75% WBE. Participating M/WBE subcontractors on the Ahrens team include: BLM Properties, LLC (MBE), Windstar Transportation LLC (MBE) and TraMar Contracting, Inc. (WBE). Staff from both GRG and KWI recommend award to Ahrens Contracting, Inc.

The bid alternative (site irrigation) will be accepted for the project, as it is in line with fair market and within the project budget.

GRG staff seek approval for the Ahrens Contracting, Inc. contract amount, plus a 10% contingency, for a total not to exceed amount of \$579,565.00. The available 2022 Capital Budget includes \$593,375.00 within the GRG 3/16th revenue stream for the project (402B).

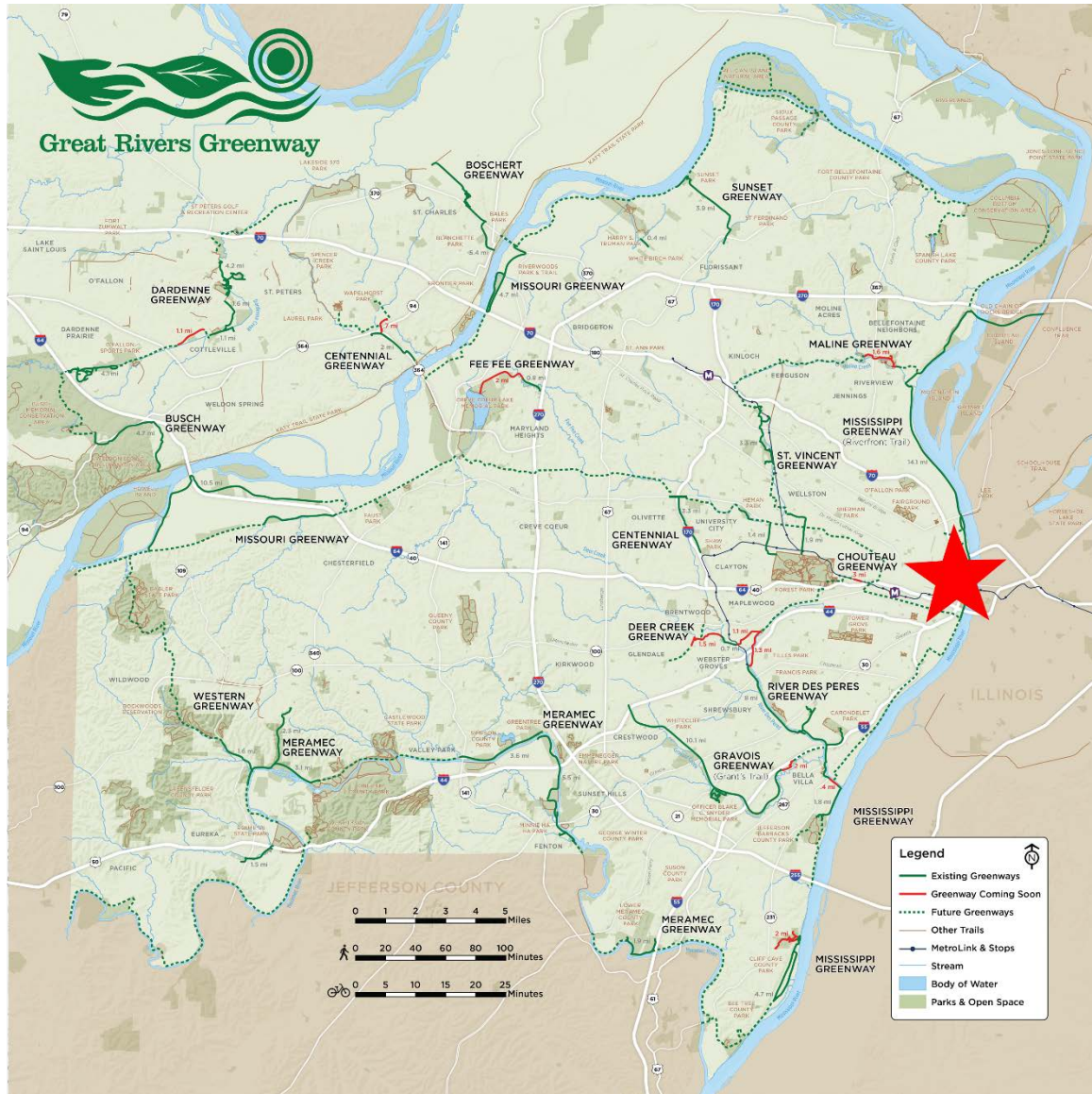

WHY AND/OR HOW:

The National Park Service (NPS) and the District have undertaken several capital repair and improvement projects at the Gateway Arch National Park. The District procured the services of Trivers Associates, Inc. (Trivers) to develop design and construction documents as well as provide construction assurance services for security enhancements in the Arch Museum and Visitor Center. Trivers' contract was for \$49,850 and the scope of work included supporting the bid process. This project received no bids the first time it was advertised and therefore, the project was reevaluated and bid again. The project was subsequently awarded to HOF Construction. Trivers' scope and fee only included one bid process, therefore, since we had two bid processes, to complete the remainder of their construction assurance services, they will require an additional \$1,630 for a total contract value of \$51,480, which now requires board approval.

Staff are requesting the board of directors authorize the CEO to negotiate and enter into a contract amendment with Trivers for \$1,630 for construction assurance services.

**A RESOLUTION APPROVING A CONTRACT
AMENDMENT NOT TO EXCEED \$1,630 WITH
TRIVERS ASSOCIATES, INC. IN CONNECTION
WITH THE MISSISSIPPI GREENWAY AND
AUTHORIZING OTHER ACTIONS AS NECESSARY
TO EFFECTUATE THE SAME.**

WHEREAS, the Metropolitan Park and Recreation District d/b/a The Great Rivers Greenway District (the "District") is a metropolitan park and recreation district authorized under Section 67.1700 to 67.1769 of the Revised Statutes of Missouri, as amended (the "District Act");

WHEREAS, pursuant to the Clean Water, Safe Parks, and Community Trails Initiative ("Proposition C"), the qualified voters of St. Louis County, St. Charles County, and St. Louis City approved the creation of the District;

WHEREAS, the District was formed to undertake the development, operation and maintenance of a public system of interconnecting trails and parks throughout the areas and counties comprising the District (the "District's Mission");

WHEREAS, in furtherance of the District's Mission, and in accordance with the Bylaws of the District, the District adopted "Building the River Ring" as the Regional Plan for the District, and which contains the comprehensive plan of the District, its existing and proposed interconnecting greenway, park and trail projects, and any proposed land acquisitions (the "River Ring Regional Plan");

WHEREAS, the Mississippi Greenway is shown as a regional greenway in the River Ring Regional Plan (the "Mississippi Greenway");

WHEREAS, the District desires to improve the River Ring in furtherance of the River Ring Regional Plan by making security enhancements to the Gateway Arch National Park (the "Project");

WHEREAS, pursuant to the approval of the Safe and Accessible Arch and Public Parks Initiative ("Proposition P") and Section 67.1712.2 of the District Act, the governing bodies of St. Louis City and St. Louis County imposed a three-sixteenths of one cent sales tax for the purpose of funding the operation and maintenance of the portion of the District located within St. Louis City and St. Louis County;

WHEREAS, the 2022 CAR 3/16 Capital Budget was approved by the District pursuant to Resolution 2021.99 and further amended by Resolution 2022.50;

WHEREAS, the CAR 3/16 Capital Budget included line item (897B) for the Project;

WHEREAS, the District authorized the Chief Executive Officer to negotiate and enter into a contract with Trivers Associates, Inc. for design and construction assurance in furtherance of the Project, and the District subsequently entered into a contract with Trivers Associates, Inc.;

WHEREAS, the District desires to enter into a contract amendment with Trivers Associates, Inc. in order to amend the compensation under the existing contract;

WHEREAS, the District desires to (i) authorize the Chief Executive Officer to negotiate and enter into a contract amendment with Trivers Associates, Inc.; and (ii) take any actions necessary or appropriate to effectuate the same; and

WHEREAS, at a meeting of the Board of Directors of the District (the "Board"), convened at 11:30 am, on October 11, 2022, at the District Offices at 3745 Foundry Way, St. Louis, Missouri, at which was present a quorum of the Board, the Board took the action further described herein.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE METROPOLITAN PARK AND RECREATION DISTRICT D/B/A THE GREAT RIVERS GREENWAY DISTRICT AS FOLLOWS:

1. The Board authorizes the Chief Executive Officer to negotiate and enter into a contract amendment with Trivers Associates, Inc. in an amount not to exceed \$1,630.
2. The Board authorizes the Chief Executive Officer or her designees to take such further action, and execute such other documents, certificates and instruments as may be necessary or desirable to carry out and comply with the intent of this Resolution.
3. All actions heretofore taken by the officers, agents, and employees of the District related to the transactions contemplated by this Resolution are hereby ratified and confirmed.
4. The portions of this Resolution shall be severable. In the event that any portion of this Resolution is found by a court of competent jurisdiction to be invalid, the remaining portions of this Resolution are valid, unless the court finds the valid portions of this Resolution are so essential and inseparably connected with and dependent upon the void portion that it cannot be presumed that the Board would have enacted the valid portions without the invalid ones, or unless the court finds that the valid portions

standing alone are incomplete and are incapable of being executed in accordance with the legislative intent.

5. This Resolution shall be in full force and effect immediately from and after its adoption as provided by law.
