### WHY AND/OR HOW:

This action requests approval of the Feasibility Study and Concept Plan (the "Study") document prepared by Lochmueller Group, Inc. (Lochmueller) and its sub-consultants in connection with the Maline Greenway: West Florissant Avenue to Bella Fontaine Park West segment in St. Louis County.

### BACKGROUND

In 2010 and 2011, Great Rivers Greenway (GRG) worked in partnership with the various municipalities of north St. Louis County to study the Maline Creek corridor. The study area covered a 1-mile wide area (1/2-mile on each side of the creek) and ran through portions of the cities of Berkeley, Kinloch, Ferguson, Jennings, Moline Acres, Bellefontaine Neighbors, Riverview, and St. Louis, as well as unincorporated St. Louis County. GRG staff worked with a Citizen Advisory Committee and a Technical Advisory Committee to develop

the 2011 Maline Greenway Concept Plan, which now serves as the master planning document that identifies the general alignment for the 8-mile long Maline Greenway.

The completed portion of Maline Greenway trail runs 2.12 miles from St. Louis County's Bella Fontaine West Park, eastward through Bella Fontaine Park, and ends at St. Cyr Road near where Maline Creek crosses from Bellefontaine Neighbors into the City of St. Louis. In 2024, GRG will begin constructing a separate 1.6-mile segment between the Ted Jones Trail and West Florissant Avenue in the City of Ferguson. Between these two (2) sections of trail is an approximately 2-mile gap within the cities of Ferguson, Jennings, and unincorporated St. Louis County. That gap has become project (296) Maline Greenway: West Florissant Avenue to Bella Fontaine Park West, which is the focus of this Board action.


### FEASIBILITY STUDY AND CONCEPT PLAN

The 2011 Maline Greenway Concept Plan identified a creek side alignment that would cover this 2-mile gap. Due to severe site constraints such as flooding, floodplain permitting, and environmental safety concerns, an alternative alignment was also identified for planning phase analysis (see first map graphic). In August 2022, GRG staff procured a consultant team led by Lochmueller and Vector Communications Corporation to begin the process of exploring and analyzing greenway route options along the two (2) main corridors under consideration. Over the course of a year, the feasibility study process weaved together technical analysis and evaluation with community engagement and input at every step along the way. The team collaborated heavily with St. Louis County and the cities of Ferguson and Jennings, local schools, and the local police departments. Most importantly, a Community Advisory Committee comprised of elected officials, local residents, and regional stakeholders helped guide the collection of data and analyze results to ultimately generate a recommended final alignment to be developed further in the design phase.

The Study evaluated potential greenway alignments, trailhead configurations, neighborhood connections, crossing strategies and integration opportunities with adjacent development projects. Community feedback, risk assessments, cost estimates, utility coordination, environmental impact and experiential factors were weighed in determining final recommended greenway alignment (see the second map graphic). The greenway primarily follows an Ameren operated aerial utility easement through a strip of land owned by St. Louis County Parks. The proposed trail corridor traverses through mostly publicly owned land and only five (5) privately owned parcels. This provides

opportunities for the greenway to create an unique linear park experience for users while directly connecting to seven (7) residential streets in the neighborhood west of Halls Ferry Road. The final recommendation for how the greenway will cross Halls Ferry Road will be made through a future scope of work procured at the start of 2024, subject to future Board approval. Options include an at-grade crossing at the intersection with Lucas-Hunt Road, as well as a grade-separated bridge structure over Halls Ferry Road itself.

Staff recommends approval of the Study. At the beginning of 2024, additional scopes of work will be brought to the Board for future consideration and will include design phase services included in GRG's typical professional services scope template.

### WHY AND/OR HOW:

The Board approved Resolution 2022.92 last year, which approved the Prequalification List for Planning, Landscape Architecture, Engineering, Architecture and Surveying services. This is the Build and Sustain team's resource for professional services on all greenway related projects. The RFQ covers work from January 2023 through December 31, 2025. In past years, GRG policy was to not allow new firms onto the prequalification list during the two-year period. For the current 2023-2025 period, staff modified the

RFQ to allow new firms to submit their qualifications during the 3rd quarter of 2023 and 2024.

Staff issued the 2023 RFQ in September 2023, and received thirteen (13) new submittals which were due on September 29, 2023. Staff reviewed the submittals and recommended that seven (7) firms be automatically included on the Prequalification List, as they all process the professional services detailed in the RFQ. The remaining six (6) were new firms and staff coordinated 20-minute interviews with each of them to learn about the firm, its projects and other activities. All six (6) firms are recommended to be included as well on the updated Prequalification List.

The attached listing includes the firm's name, the zip code of their office, Woman, Minority or Disadvantaged Business (WBE, MBE or DBE) designation, and the professional service(s) they submitted and are qualified to perform.

Staff will reissue the RFQ again in 2024 to allow new firms the opportunity to join the Prequalification List.

### WHY AND/OR HOW:

The District has either primary maintenance responsibility or supplements the care of certain greenways throughout the District. District staff conducted a public request for bids for these services as well as for asneeded maintenance tasks not associated with an active project or greenway. Bids were requested for an initial one-year contract term with two (2) one-year renewals.

Seven (7) firms submitted sealed bids for the individual greenway segments or scope of work as well as hourly labor rates for as-needed services based on an average of 2000 hours annually for work that is not a part of their normal scope of work (i.e., vandalism, car accidents, weather related incidents, as well as special projects that arise throughout the year). The summary above is based on the scope of work and an assumption of 2000 hours of as-needed services.

District selection criteria is done on a "lowest and best" basis. Because the performance of these services in a timely and professional manner is critical to safety and user experience, it is important that the firm we select is both qualified and has the capacity to perform all of the services we contemplate. Staff conducted a thorough analysis of each submittal, including reference checks, review of past projects, phone interviews and

review of the proposals by a current landscape consultant currently under contract. Staff's conclusion was that TRC offered the lowest and best bid based on their past performance on both District projects and others in similar size and scope, staffing capacity, ability to perform a variety of asneeded services and reasonable costs compared to past contracts. Below is an itemized break-down for TRC Outdoor, LC's (TRC) submitted bid. TRC has agreed to utilize an MBE firm for their lawn mowing (estimated to represent about 12% of the contract) and is currently working with a WBE firm for their trash removal and hauling, which based on past experience would be between 3-5% of the total contract amount.



### WHY AND/OR HOW:

The District has been providing supplemental security and monitoring on greenways since 2014. It has come in several different forms from police officers, guides and security guards. When Kiener Plaza was reopened and the District assumed operations and maintenance of the park, a full-time security guard was deployed initially for sixteen (16) hours a day and then for twenty-four (24) hours a day one (1) year later. Bike-mounted security

guards have been utilized to provide supplemental monitoring and oversight on the St. Vincent, River des Peres and Mississippi Greenways. When Katherine Ward Burg Garden opened in early 2023, no security was present onsite, but rather the park was observed remotely by guards at Kiener Plaza. This was eventually changed to a guard staffed in a vehicle parked onsite during overnight hours in response to illegal and after-hours activity against park rules.

The District solicited bids for supplemental security for 2024-2028 and received ten (10) submittals. This time frame matches the agreement with the City of St. Louis requiring the District to provide a guard at a new security booth on Leonor K. Sullivan Blvd. on the Mississippi Greenway. From the submittals, four (4) firms were selected for in-person interviews. District staff evaluated the firms' ability to perform the duties outlined in the scope of work, their approach and willingness to utilize existing technology and infrastructure, experience with special events, their ability and approach to monitoring our remote sites as well as their ability to meet our MBE/WBE contract goals. After a thorough evaluation, it is the District staff's recommendation to award the contract to Gardaworld. They were able to provide a value-added approach to remote monitoring, have a strong presence in St. Louis with the ability to modify their shifts as needs change, past performance on District projects and other similarly sized clients and ability to utilize minority and women-owned business enterprises to work toward District goals.

District staff is requesting that the Board of Directors authorize the CEO to negotiate and enter into a contract with Whelan Security Co. d/b/a GardaWorld Security Services to provide security at Kiener Plaza, Chain of Rocks Park, Katherine Ward Burg Garden and on the Mississippi, River des Peres and St. Vincent Greenways. These services would be for a combination of staffed security, remote monitoring, bike-mounted patrols and on-call response to incidents.



To streamline planning for site control and long-term care of the Greenway, District staff and the Board of Public Service (BPS) are seeking an overarching license agreement that will outline the general terms agreed to by the City of St. Louis and the District for using public right of way (ROW) for the Brickline Greenway. Each subsequent segment of the Greenway that



#### WHY AND/OR HOW:

This action is to approve a new contract with Vector Communications Corporation for professional services to support engagement efforts in North St. Louis County.

#### Background

This recommended engagement effort for North St. Louis County is the direct result of authorized work related to the Regional Plan Update 2022 and GRG Board resolutions 2020.17, 2020.18 and 2022.45. The 2022 Regional Plan Update, and its planning process and survey, identified a need for targeted engagement in communities where greenway awareness, use and access may be low, and to begin planning for new greenway projects as

determined by engagement. Two (2) regionwide online surveys conducted in 2021 noted that people who know Great Rivers Greenway (GRG) tend to be recurring greenway users and those who are located near existing greenways. Results of this survey identified a clear gap in responses from North St. Louis County stakeholders, which contain approximately five (5) miles of active greenway to date within the 76 square mile area targeted for this effort. Engagement for the 2022 Regional Plan Update also revealed a need for additional outreach to increase participation from North St. Louis County residents and stakeholders; however, after additional efforts were made to increase participation, North St. Louis County remained underrepresented as noted in a 2021 Regional Plan Update survey responses report.

#### Details on this Action

Earlier this year, four (4) engagement firms were selected from the 2021-2023 Civic and Community Engagement Prequalification List and were invited to interview for the project with GRG staff. Staff selected Vector Communications Corporation based on their previous and current engagements efforts in North St. Louis County as well as their extensive expertise in engaging audiences and preparing a robust strategy throughout next year. Targeted engagement for this project will seek to build awareness and form relationships, to identify community interests, priorities and needs, and to build organizational trust ahead of any greenway planning processes within the identified North County footprint. The ultimate outcome of this engagement is to define a greenway project or projects for North St. Louis County for future consideration to expand the greenway network.

The targeted project area for this effort will be bounded by I-270 (south), Highway 370 (west), Missouri River (north) and Mississippi River (east). The municipalities included in this effort include Black Jack, Bridgeton, Florissant, Hazelwood, Old Jamestown, Spanish Lake and Unincorporated St. Louis County. Engagement will involve elected officials, City of St. Louis and municipal staff, residents, business owners and other stakeholders, and will include stakeholder meetings, online surveys, pop-up and tabling events, open house events and listening sessions. Custom maps highlighting demographic, economic and social data will be used to ensure equitable participation throughout the engagement process.

The result of this engagement will provide key recommendations for efforts to further build relationships and identify potential greenway projects within North St. Louis County. It is GRG's goal to identify and include one or two projects in the 2025 Capital Budget next autumn.



#### WHY AND/OR HOW:

(EDSI) not to exceed \$47,528, subject to future appropriation in connection with Construction Management services for the Meramec Greenway: Signage Betterment from George Winter Park to Unger Park in St. Louis County.

#### PROJECT INFORMATION

In 2022, the Great Rivers Greenway (GRG) Board of Directors approved a contract with EDSI to provide design services to develop a set of construction plans to upgrade signage and brand graphics for a segment of the Meramec Greenway in the City of Fenton (City). Additionally, EDSI was scoped to assist GRG and the City to review the on-street segment of the greenway through Old Town Fenton for possible improvements or adjustments of the on-street segment to provide the safest pedestrian and bicyclist experience. This project will update the existing greenway wayfinding and interpretive signage to make navigation clear and safe to

greenway users traveling between the two St. Louis County Parks which is approximately 4.5 miles of greenway. With the new I-44 Meramec River Bicycle and Pedestrian Bridge now open, the signage will reflect the new river crossing and tie to the new signage on the bridge. Additionally, under the new I-44 bridge, a vertical separation (barrier) will be constructed between the Meramec Greenway and Yarnell Road under the bridge for added greenway user safety. The bridge columns will be enhanced with GRG environmental graphics which has been approved by MoDOT. The GRG Foundation provided funding to GRG for a portion of the design costs with GRG providing the remainder.

#### SELECTION PROCESS


In January of 2023, three (3) companies submitted their qualifications from a GRG solicitation to provide Construction Management Services for multiple GRG projects. This Meramec Greenway project was in the "Betterment" projects bundle, and the companies that submitted their qualifications were Kozeny-Wagner, Inc., Interface Construction Corp and EDSI). Submittals were reviewed and EDSI was selected as the best firm to perform the Construction Management and Administration services, since they were the most qualified firm and familiar with the design of this project. EDSI is a civil engineering firm and has the experience and capabilities to design and provide construction oversight in coordination with MoDOT, GRG and the City of Fenton specifications and expectations. EDSI is a DBE/MBE firm.

#### PROJECT FUNDING AND SCHEDULE

The total construction cost for the removal of old signage, installation of the new signage, as well as the installation of vertical separation under I-44 and environmental graphics is \$200,000 with contingency. The GRG Foundation will provide \$65,000 towards the construction costs with GRG providing the remainder of \$135,000. The project is expected to be publicly bid in December or January and start construction in Spring of 2024 and completion later in the year.

#### SCOPE OF WORK AND FEE

The Scope of Services includes the following tasks: A) Preconstruction Phase: Construction Plans, Specifications and Cost estimate review, Bidding assistance, tabulation and recommendation; and B) Construction Phase: Construction inspections and observations, Schedule, and budget/invoice reviews, review and authorize any change orders, conduct materials testing, manage progress meetings and other construction coordination items. EDSI has a subconsultant SCI Engineering, Inc. on the team to conduct the material testing services. Total fee for the proposed tasks is \$47,528 to be spent in late 2023 and 2024. Available budget in 2023 will cover any costs this year with the majority of EDSI's work will be in 2024.



Although Great Rivers Greenway ("GRG") is not an eligible applicant, Missouri cities and counties are eligible for the State Grant, and St. Louis County agreed to serve as the applicant for a \$2,500,000 grant application on GRG's behalf for the 1.7-mile St. Vincent Greenway: Robert L. Powell Place to St. Charles Rock Road project. The 2022 submitted application was ultimately successful, and St. Louis County has entered into a grant agreement with the State of Missouri. GRG is already working with the County Department of Transportation, the cities of Wellston and Pagedale, and others, as this \$6,000,000 project is planned for construction over three (3) phases between 2024 and 2026. The State Grant requires all selected projects to be completed by September 2026, and the \$2,500,000 is to be applied to all three (3) phases of project construction (see the map below for the alignment of the greenway corridor and respective phase areas). Therefore, in anticipation of Phase 1's start of construction in 2024, the County has submitted to GRG a funding agreement for future dispersal of State Grant funds.

The \$2,500,000 State Grant application originally submitted by the County requires a minimum 50% local match, and GRG agreed to provide the matching funds between 2024 - 2026 when the Board approved Resolution 2022.86 in November 2022. As GRG has already received a federal Surface Transportation Program ("STP-S") grant of \$2,750,000 from East-West Gateway Council of Governments, this new State Grant offsets GRG's total construction costs to build the greenway. #### WHY AND/OR HOW:

This action is to accept Surface Transportation Program-Suballocated (STP-S) and Congestion Mitigation and Air Quality (CMAQ) project administration and approve grant agreements for at least \$10,612,000 with the Missouri Department of Transportation in connection with the Brickline Greenway: North Connector Phase 1 (shown in magenta on the map below). In summer 2022, GRG began discussions with the City of St. Louis for options to expand improvements to the non-greenway side of the Brickline Greenway: North Connector Phase 1. The Rebuilding American Infrastructure with Sustainability and Equity (RAISE) grant awarded pursuant to Resolution 2021.53 includes \$15 million in federal funding for greenway improvements on the west side of Grand Blvd. In numerous public meetings and engagements, GRG heard from the community that improvements on the east side of Grand Blvd. are just as important in order to transform Grand Blvd. and help economic development and neighborhood improvement efforts. Pursuant to Resolution 2023.03, STP-S and CMAQ applications were prepared and submitted in collaboration with the City of St. Louis.

In August 2023, the City of St. Louis and GRG received notice of award of additional STP-S and CMAQ grant funding totaling over \$10.6 million for sidewalk and streetscape improvements opposite the greenway on the east side of Grand Blvd. The award enables a complete street reconstruction between Natural Bridge and Cass Avenues. The STP-S and CMAQ programs are integral to the effort, and funding requires the greenway (RAISE) and non-greenway (STP-S/CMAQ) projects to be separate and independent. The projects would have separate design and permitting requirements and be bid and built under separate contracts. Standalone plans, specifications and estimates are needed. Design and permitting for the STP-S and CMAQ funds must be completed and approved on or before September 30, 2025. Approval of this action allows GRG to administer the STP-S and CMAQ projects and enter into the necessary grant agreements with the Missouri Department of Transportation.





### WHY AND/OR HOW:

This action is to authorize staff to submit materials to the Missouri Department of Natural Resources ("MoDNR") for the \$15 million in State Funds provided for the development of the Brickline Greenway. The Missouri General Assembly though House Bills 6,19 and 20 of the 2023 Legislative Session included funding for the development of the Brickline Greenway in the FY 2024 Budget. The Governor signed the bill in August 2023 with \$15 million allocated to Great Rivers Greenway ("GRG") to be administered by MoDNR. MoDNR has developed a guidance document for the project sponsors which will be administered by MoDNR's Financial Assistance Center. The twelve (12) project sponsors are a variety of drinking water, wastewater, stormwater and development projects around the state. The program is a reimbursable program, similar to the various transportation grants GRG receives for projects. In this situation, there is no match required for the \$15 million.

As the first step in the process, all project sponsors are required to fill out a funding application and submit various documents for MoDNR review. For GRG, staff will prepare an application and supporting materials related to the Brickline projects receiving the \$15 million. Staff has a list of three (3) upcoming Brickline construction projects over the next two (2) to three (3) years. While the grants could be used for design work, we are trying to use the \$15 million for construction as much as possible. However, the application states that projects need to be obligated and funds expended by June 2025, per the General Assembly's legislation. The deadline may be extended but the General Assembly would need to re-appropriate the funding for a future fiscal year. This will be a critical factor in determining which Brickline projects are submitted for the grant funds. The application includes a "Resolution of Governing Body of Applicant (Authorized Representative) Form" which must be signed by the GRG President of the Board of Directors. This form acknowledges that GRG is

authorizing the Chief Executive Officer to submit the application as well as the Financial Assistance Agreement which would be generated for execution between GRG and MoDNR at a later date. GRG staff will seek authorization from the Board of Directors to authorize the Agreement in the coming months.

#### WHY AND/OR HOW:

This action requests to authorize the CEO to negotiate and enter into a contract with Horner & Shifrin, Inc. not to exceed \$55,000 in connection with construction management services for the Centennial Greenway: Signage Betterment & Replacement from Creve Coeur Park to Katy Trail State Park in St. Louis and St. Charles counties.

#### Background

In 2022, the Great Rivers Greenway (GRG) Board of Directors approved a contract with Horner & Shifrin, Inc. to provide design services to develop a set of construction plans to upgrade trail signage and environmental graphics through Creve Coeur Park to the Katy Trail in St. Louis and St. Charles counties. This is an ambitious project working with St. Louis County Parks, Missouri State Parks, Missouri Department of Transportation and St.

Charles County Parks as this project impacts various greenway and other trail facilities. (see sign example below)
The project goals are:

- Upgrade signage and brand graphics to ensure an excellent experience where users can navigate easily between the Centennial and Fee Fee Greenways, KATY Trail, and the amenities at Creve Coeur Park.
   Improve the wayfinding system using signage to denote the various trails within Creve Coeur Park which is very confusing to non-regular park and trail users.
- Identify art and environmental graphics opportunities working with GRG and St. Louis County Park staff.
- Improve the wayfinding system, maps, locations or other signs, remove sign clutter and enhance user experience.

A Request for Qualifications (RFQ) for Construction Management services was issued in August and three submittals were received. All three firms were interviewed and Horner & Shifrin, Inc. was selected due to their extensive background on the project and expertise on similar projects. Horner and Shifrin, Inc. provided a scope and fee of \$55,000 which includes a minimum of 10% for ABNA Engineering, Inc.(M/WBE) for materials testing and inspection services.

The scope of work would include the construction management services for the installation of custom signs throughout Creve Coeur Park, replacing GRG signs at the Katy Trail State Park with new GRG signage, and improving a trail roundabout at a major GRG connection point of Fee Fee, Centennial and the future Missouri Greenways within Creve Coeur Park. GRG staff is working to finalize the design with all the various partners and bid the project in the next month or two. Fabrication of the signage will dictate the overall installation of the signage in 2024.
