Meeting Minutes

What We Heard: Funding Allocation Feedback:

- It is difficult to know the specifics of the corridors to know if the 1% of construction allocation is appropriate. It does serve as a starting point and all routes should be accessible and "equal" in terms of the artwork.
- Consider a cost/SF or per mile for the art budget

Where We are Headed- North Connector Feedback:

- There are long stretches without nodes for artwork so how were the nodes determined? The nodes were determined by proximity to intersections, access to both east and west sides of the street, space constraints, and need for other amenities.
- Research could be done to determine routes and paths to food such that artwork could potentially be placed within those routes and seen by the most people.
- Since the 4 parks are the cornerstones of the Brickline Greenway, consider art in Fairground
 Park so that it is the "prize" at the end/beginning of the North Connector. Fairground Park is
 outside the boundary of the Brickline so this needs to be discussed further.
- Activation of the Brickline is critical.
- Community Engagement activities continue with approx. 370 community engagement touches each year since 2020.
- Curatorial consultant would be a 2 year opportunity pending funding from a potential donor.
 The funding would need to cover the cost of the curator and a local coordinator position. The curator should be familiar with the community and be able to collaborate with the coordinator.
 This would be a "layering on" of work in cooperation with the work that Via Partnership is doing to develop the Corridor Plans. This work would focus on the North Connector but be flexible enough should the need for curatorial consultant expands to other Brickline corridors.
- The curator(s) do not have to be from St. Louis, but they need to display a sensitivity to the
 history and context of the community and St. Louis at large as part of their demonstration of
 qualifications.
- If a local and non-local curator partnership is pursued, the relationship should be collaborative and not hierarchical.
- Recommendation is for a small working group to help advise on the development of the curator RFP.
- Curator procurement schedule is partially dependent on securing a funding partnership.
