Special Use Permit Application for Old Chain of Rocks Bridge

The Metropolitan Park and Recreation District d/b/a The Great Rivers Greenway District ("Great Rivers Greenway") is a multi-jurisdictional special park district serving as a political subdivision of the state of Missouri. Great Rivers Greenway was created in 2000 through a public referendum in the City of St Louis, St. Louis County, and St. Charles County. Great Rivers Greenway is making the St. Louis region a better place to live by developing the River Ring, a 600-mile system of interconnected greenways, parks and trails. Through this effort, Great Rivers Greenway provides active transportation alternatives, preserves nature, improves health and increases the economic vitality of the St. Louis region. The Old Chain of Rocks Bridge is owned by the City of Madison, Illinois and leased by Great Rivers Greenway for use as a bicycle and pedestrian bridge along the Great Rivers Greenway's Mississippi Greenway, connecting to trails in Illinois operated by the Metro East Parks and Recreation District. Under special conditions, the Old Chain of Rocks Bridge may be utilized by alternative uses at the discretion of the Executive Director of Great Rivers Greenway, as outlined herein this Special Use Permit Application (the "Application").

- **Type 1.** Single event (i.e. wedding, photo shoot, ceremony) that lasts one (1) hour or less. Bridge is to remain open at all times for public use. An eight (8) foot wide lane shall remain open at all times to maintain access by bicycles, pedestrians and maintenance vehicles. Closest parking lot access will be via the Illinois side of the bridge. No motor vehicle access permitted under **Type 1** event.
- Type 2. Vehicular bridge crossing up to twenty (20) vehicles. Permittee is allocated one (1) hour of use on the bridge and parking lot located in Illinois. Bridge is to remain open at all times for public use. Vehicles to travel single file in the center of the bridge at a speed no greater than fifteen (15) miles per hour. An eight (8) foot wide lane shall remain open at all times to maintain access by bicycles, pedestrians and maintenance vehicles. A representative of Great Rivers Greenway shall be present during the entirety of the scheduled event. Permittee will meet a representative of Great Rivers Greenway at the Illinois parking lot. The representative will allow vehicle traffic entrance onto the bridge and will open the gate on the Missouri side to allow vehicle to exit onto Riverview Drive in St. Louis. Vehicles are limited to a gross vehicle weight of under 7500 lbs. and should maintain at least one (1) vehicle length between each vehicle.
- **Type 3.** Vehicular bridge crossing over 20 vehicles. Permittee is allocated two (2) hours of use on the bridge and parking lot located in Illinois. Bridge is to remain open at all times for public use. Vehicles to travel single file in the center of the bridge at a speed no greater than fifteen (15) miles per hour. An eight (8) foot wide lane shall remain open at all times to maintain access by bicycles, pedestrians and maintenance vehicles. A representative of Great Rivers Greenway shall be present during the entirety of the scheduled event. Permittee will meet a representative of Great Rivers Greenway at the Illinois parking lot. The representative will allow vehicle traffic entrance onto the bridge and will open the gate on the Missouri side to allow vehicles to exit onto Riverview Drive in St. Louis. Vehicles are limited to a gross vehicle weight of under 7500 lbs. and should maintain at least one vehicle length between each vehicle.
