WHEREAS, the Metropolitan Park and Recreation District d/b/a The Great Rivers Greenway District (the "District") is a metropolitan park and recreation district authorized under Section 67.1700 to 67.1769 of the Revised Statutes of Missouri, as amended (the "District Act");

WHEREAS, pursuant to the Clean Water, Safe Parks, and Community Trails Initiative ("Proposition C"), the qualified voters of St. Louis County, St. Charles County, and St. Louis City approved the creation of the District;

WHEREAS, the District was formed to undertake the development, operation and maintenance of a public system of interconnecting trails and parks throughout the areas and counties comprising the District;

WHEREAS, pursuant to the Bylaws of the District, the Board of Directors of the District (the "Board") shall appoint an Independent Auditor for an annual inspection of the District's records and shall require an annual financial audit and a comprehensive written report of findings and recommendations of the Independent Auditor to be submitted and presented to the Board by the June Regular Meeting;

WHEREAS, the District's Committee on Budget and Finance has recommended acceptance of the 2024 Financial Statement Audit by the Board;

WHEREAS, at a meeting of the Board of Directors of the District (the "Board"), convened at 11:30 am, on June 10, 2025, at the District Offices at 3745 Foundry Way, Suite 253, St. Louis, Missouri, at which was present a quorum of the Board, the Board took the action further described herein.

WHY AND/OR HOW:

This action is to approve a \$157,405 contract with PGAV Planners, LLC (PGAV) to provide planning and design services for the Centennial Greenway: Creve Coeur Park to I-270 in West St. Louis County.

Background

The vision for the Centennial Greenway is to create a regional link between St. Charles County, St. Louis County, and the City of St. Louis, connecting 370 Lakeside Park, Katy Trail State Park, Creve Coeur Park, and Forest Park. Currently, there is a renewed effort to advance numerous Centennial Greenway segments to achieve the grand vision. This particular project and scope will focus on the nearly three-mile segment between Creve Coeur Park and I-270 in unincorporated St. Louis County. This project is an important backbone of the Centennial Greenway and would connect many St. Louis County neighborhoods west of I-270 to Creve Coeur Park and the numerous trails in and around the park.

Plans for the Centennial Greenway between Creve Coeur Park and I-270 were prepared in 2008, but Great Rivers Greenway was unable to assemble the necessary easements to advance implementation. In 2024, Old Farm Estates and other neighborhoods in the area reached out to Great Rivers Greenway with renewed interest in the greenway and a willingness to work with GRG to get the greenway completed. With new partnerships and growing momentum to complete the Centennial Greenway, GRG wishes to complete the greenway design and include implementation funding in the Capital Improvement Plan for upcoming budget years. PGAV was selected as the planning and design firm for this segment as part of 10 new projects that staff assembled an Invitation to Interview for various consultants from the Prequalified Vendor List.

PGAV has provided a scope and fee of \$157,405 which includes eviewing the previous 2008 design work and making recommendations for the future design of the greenway. The PGAV design team will take part in site visits, workshops, stakeholder discussions and provide exhibits, proposed layouts, and renderings of possible opportunities for user experiences along the trail. While the previous design work will inform the process as much as possible, existing conditions have changed since 2008. Additionally, GRG's design standards and other best practices have been incorporated into GRG's projects which were not developed at the time the original plans were designed.

PGAV staff will coordinate efforts with Shockey Consulting Services, LLC, which has been selected as the public engagement firm for this project under a separate contract. The future greenway is located in Unincorporated St. Louis County, close to Maryland Heights and Creve Coeur. The project team will work with elected officials, county staff members, residents, business owners and other stakeholders in the area. The ultimate goal of the project is to define the Centennial Greenway project, expand the greenway network in St. Louis County, and advance regional access on the Centennial Greenway.

WHY AND/OR HOW:

This action is to approve a \$74,850 contract with Shockey Consulting Services, LLC (Shockey Consulting) to provide engagement services for Centennial Greenway: Creve Coeur Park to I-270 in west St. Louis County.

Background

The vision for the Centennial Greenway is to create a regional link between St. Charles County, St. Louis County, and the City of St. Louis, connecting 370 Lakeside Park, Katy Trail State Park, Creve Coeur Park, and Forest Park. Currently there is a renewed effort to advance numerous Centennial Greenway segments to achieve the grand vision, including the nearly three-mile segment between Creve Coeur Park and I-270 in unincorporated St. Louis County. This project is an important backbone of the Centennial Greenway and would connect many St. Louis County neighborhoods west of I-270 to Creve Coeur Park and the numerous trails in and around the park.

Details on this Action

Shockey Consulting will provide public engagement services in conjunction with the planning and design consultant work to be completed by PGAV under a separate contract. This will include roadshow presentations to Homeowners Associations (HOAs) and neighborhood groups, an online survey, and a community open house. Engagement for this project will seek to ensure residents and stakeholders are well-informed and allow the community to participate in the decision making process. This future greenway is located in unincorporated St. Louis County, close to Maryland Heights and Creve Coeur. Engagement will involve elected officials, county staff members, residents, business owners, and other stakeholders. The projected outcomes of this engagement will be to define the Centennial Greenway project, expand the greenway network in St. Louis County, and advance regional access on the Centennial Greenway.

Earlier this year, four (4) engagement firms replied to our Invitation to Interview after being selected from our existing Prequalified Vendor List. All four (4) of the firms were invited to interview for the project with GRG staff. Staff selected Shockey Consulting based on their prior work with GRG on over twelve (12) projects, including, recently, for the Centennial Greenway in the City of Olivette and Baltic Creek Greenway Master Plan in St. Charles County; their highly organized engagement approach; and their broad knowledge and understanding of community engagement techniques.

The scope and fee for this contract is \$74,850. Staff is recommending approval of the contract with Shockey Consulting.

This Board Action requests to authorize the CEO to negotiate and enter into a Utility Relocation Agreement with Missouri American Water Company ("MAWC") in connection with St. Vincent Greenway: Robert L. Powell Pl. to St. Charles Rock Road.

The project team has been coordinating with multiple utility companies to identify and resolve conflicts within all three project phases of St. Vincent Greenway. MAWC operates and maintains water infrastructure within the public right-of-way. The proposed greenway alignment conflicts with three (3) meter enclosures, two-hundred and forty (240) feet of water mains, five (5) water service lines, three (3) hydrants, service valves and meters. These conflicts occur along 70th Street from Kingsland Ave. to Plymouth Ave. Due to the highly constrained right-of-way conditions within this corridor, the relocation of MAWC facilities is necessary in order to construct the greenway. MAWC staff have prepared a relocation cost estimate of \$296,454. In addition, GRG Staff are asking for contingency funding of \$29,656 (10%) for potential additional work needed to adjust or replace service and main valves in the field. These costs will not be known until concrete is removed. Approval of this Resolution by the GRG Board will authorize the CEO to negotiate and enter into an agreement not to exceed \$326,110. Upon execution of the agreement and payment of the relocation costs, MAWC will utilize their selected contractor to perform the needed utility relocations.

Project Background


The final recommended alignment for St. Vincent Greenway: Robert L. Powell Pl. to St. Charles Rock Road closes the remaining 1.7-mile gap between existing segments of greenway, and the project is now nearing final design and the start of construction. Additionally, this project has been awarded federal funds from two (2) additional sources of funding:





Along the southern side of Page Avenue between Ferguson Avenue and Kingsland Avenue (approximately 0.2 miles long), the proposed St. Vincent Greenway is located primarily within MoDOT ROW. Using GRG's design plans, MoDOT is developing comprehensive construction documents that include the greenway scope for bidding and construction as part of their overall project. The greenway improvements along Page Avenue include Great Streets Initiative amenities matching those previously installed around Pagedale Town Center by the City of Pagedale. GRG provided design files to MoDOT for integration into their plan set for MoDOT to bid and construct with oversight provided by GRG's Construction Manager during construction. Construction activity is anticipated to begin in August 2025. The current Cost Estimate for Phase 2 construction is approximately \$370,177.
- **Phase 3 (GRG construction):** In March 2023, the City of Pagedale approved and entered into a Construction, Operations, and Maintenance Agreement with GRG, thereby approving the overall alignment, authorizing its construction within City

limits, and authorizing use of City right-of-way. All sections of remaining greenway outside of Phases 1 and 2 areas will be developed as a separate construction document package to be bid by GRG, with construction managed by GRG and its Construction Manager. Construction of Phase 3 is anticipated to start following MoDOT approval of Final Plans in Summer 2025, and will finish by Summer 2026. The current cost estimate for Phase 3 construction is \$5,113,894.

WHY AND/OR HOW:

This action requests authorization to enter into a Cost Share Agreement with St. Louis County (the County) supporting the Great Streets Initiative application through East-West Gateway Council of Governments (East-West Gateway; EWG) for the Riverview Drive corridor between Chain of Rocks Park and the Saint Louis Zoo WildCare Park (WildCare Park). Ultimately, this corridor would include a 3-mile extension of the Mississippi Greenway.

Background

Envisioned in Great Rivers Greenway's 2004 Regional Plan, the concept for Mississippi Greenway is a 35-mile corridor of publicly accessible open space stretching from Columbia Bottom Conservation Area (Columbia Bottom) at the confluence of the Mississippi and Missouri Rivers to the confluence of the Mississippi and Meramec Rivers in south St. Louis County. Currently, Mississippi Greenway features a 16.2-mile trail from Chain of Rocks Park to Gateway Arch National Park on the downtown St. Louis riverfront. With the recent opening of Chain of Rocks Park there is growing interest in extending the existing trail three (3) miles north to WildCare Park and eventually another mile to Columbia Bottom Conservation Area.

The Saint Louis Zoo will open WildCare Park in 2027. WildCare Park will be a complementary destination to the Saint Louis Zoo, attracting guests with two (2) drive-through safaris and other unique guest amenities. With its anticipated annual attendance of around 425,000, it will increase the traffic on surrounding roads. The park is projected to generate nearly \$43 million in state and St. Louis City/County tax revenues by 2034, with a regional impact of over \$661 million.

In addition to the increased traffic anticipated on Riverview Drive, it is reasonable to expect development pressures on existing residential and agricultural properties along Riverview Drive and surrounding the I-270 interchange. While this represents an unprecedented opportunity for greater economic activity in the area, it may further exacerbate traffic and infrastructure issues and should be managed for compatibility to maximize economic return for the local and regional economy.

For the past two years, St. Louis County has been one of 15 communities nation-wide to participate in the US Department of Transportation's (DOT) Thriving Communities Program (Thriving Communities). Thriving Communities provides planning, technical assistance, and capacity-building support and will be complete by the end of June 2025. The program enables disadvantaged and under-resourced communities to advance a pipeline of transformative infrastructure projects that will increase mobility, reduce pollution, and expand affordable transportation options. The Thriving Communities work plan proposes strategies to improve connectivity between WildCare Park, Spanish Lake Town Center and nearby communities in north St. Louis County, including options for extending the Mississippi Greenway along Riverview Drive. GRG staff have been engaged in the Thriving Communities effort and have advocated for a greenway connection as part of the infrastructure improvements.

At this point, none of the recommended infrastructure improvements along Riverview Drive are funded, and absent a comprehensive vision for the corridor, the needed improvements are unlikely candidates for typical federal transportation grant programs.

Details on this Action

East-West Gateway Council of Governments (EWG) launched the St. Louis Great Streets Initiative (Great Streets) in 2006 to expand the way communities think of their streets. Rather than viewing a roadway project as solely a way to move more cars and trucks faster, the goal of the Great Streets Initiative is to trigger economic and social benefits by centering communities around interesting, lively and attractive streets that serve all modes of transportation. Since 2007, EWG provided grant-based funding for approximately two dozen Great Streets plans in the St. Louis region which, in turn, has made these corridors eligible--and competitive--for a variety of federal implementation funding programs. In May 2025, EWG released applications for a new Great Streets project in Missouri, in which EWG will provide \$440,000 in funds to support the project.

The Great Streets Initiative follows eight principles to guide the planning of its target corridors:

- 1. Great Streets are great places.
- 2. Great Streets integrate land use and transportation planning.
- 3. Great Streets accommodate all users and all modes.

- 4. Great Streets area economically vibrant.
- 5. Great Streets are environmentally responsible.
- 6. Great Streets rely on current thinking.
- 7. Great Streets are measurable.
- 8. Great Streets develop collaboratively.

St. Louis County has invited GRG, the Zoo and the City of St. Louis to partner on a Great Streets application for Riverview Drive. If awarded, this project would create a holistic vision for the Riverview corridor, including adjacent land uses and infrastructure improvements, while identifying potential revenue-generating mechanisms that could be leveraged for additional local and federal funding. GRG staff recommend participating in the Great Streets program, provide matching funds up to \$100,000 and provide assistance in planning and community engagement for the effort.

WHY AND/OR HOW:

This action authorizes Great Rivers Greenway (GRG) to execute a Contract Amendment with SmithGroup, Inc. (SmithGroup) to provide design services for the Brickline Greenway segment along the Gateway Mall in Downtown St. Louis, from 20th Street to Gateway Arch National Park.

Background

In 2019, GRG's Board of Directors adopted the Brickline Greenway Framework Plan which identified numerous alignments that will eventually connect Forest Park, Gateway Arch National Park, Fairground Park and Tower Grove Park in the City of St. Louis. Progress toward implementing each of these greenway segments is proceeding at separate paces, reflecting available funding, partnerships and capacity. The latest segment that Great Rivers Greenway is undertaking is along the Gateway Mall, between 20th and 4th Streets in Downtown St. Louis. Following GRG Board approval of their contract in October 2024, SmithGroup began the planning stage of this segment of Brickline Greenway which includes the three Downtown blocks that make up Kiener Plaza and the Old Courthouse.

Since 2010, GRG has been a collaborator in the public-private partnership that includes the National Park Service ("NPS"), the Gateway Arch Park Foundation ("GAPF," formerly known as the CityArchRiver Foundation), the City of St. Louis, Missouri Department of Transportation, and Bi-State Development Agency to redevelop the Gateway Arch National Park and the surrounding areas. Among the ten (10) signature components of the CityArchRiver project was the redevelopment of Kiener Plaza, which was completed in 2017 and added a visitor support building with security and maintenance operations in 2018. Following a recent evaluation of Kiener Plaza's site conditions and visitors' uses of the space, consultants from SWT Design, Inc. (SWT) recommend additional enhancements to the park, including replacement of the decomposted granite chat in the shade garden and bike parking area, renovation of the courthouse lawn and removal of the angled vehicle parking on Market Street to deter vandalism and other illegal activity affecting the park and surrounding properties. This recommendation creates an opportunity to replace the vehicle parking along Market Street with a segment of Brickline Greenway.

Details on this Action

Since late 2024, the SmithGroup design team has made steady progress planning Brickline Greenway along the 16 blocks of the Gateway Mall, from the Arch to 20th Street. Due to the upcoming improvements to Kiener Plaza (described above) designs for Brickline Greenway along the three blocks of Market Street at Kiener and the Old Courthouse (4th Street to 7th Street) are moving more quickly than the designs for the rest of the Gateway Mall. SmithGroup is nearing completion of the 30% design package for these three blocks, Referred to as "Phase 1" of this corridor, and GRG has requested a proposal to complete 100% design and bid documents in order to begin construction in 2026. Additionally, we are seeking to continue design, technical coordination with city agencies, and stakeholder/community engagement for the rest of the Gateway Mall corridor (7th Street to 20th Street) to achieve 70% completion under this contract amendment.

The proposed timeline for completing the various design packages are as follows:

Phase 1 from 4th to 7th Streets:

- Intermediate (70%) Design: November 2025

- Pre-Final (95%) Design: April 2026

- Final (100%) Design: August 2026

Deliverables for these design services include draft, intermediate and final plans, sections and details; stakeholder summaries; operations and maintenance assessment; jobspecific provisions (JSPs); cost estimates, GIS files; and final bidding documents.

Additional Phase(s) from 7th to 20th Streets:

- Preliminary (30%) Design: December 2025

- Intermediate (70%) Design: June 2026

Deliverables for these design services include a geotechnical report; renderings and video; preliminary plans, details and GIS files.

This action is to approve a contract with R.V. Wagner, Inc. for construction of the Brickline Greenway for the North Connector segment from Fairground Park to Page Blvd (Phase 1 on the map below).

In November 2021, and pursuant to Resolution 2021.53, GRG received notice of a partial Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Grant award totaling \$15 million. The RAISE Grant project begins at the southeast corner of Fairground Park at the intersection of Grand Blvd. and Natural Bridge Ave. and travels south to the intersection of Spring Ave. at Page Blvd. The project includes a greenway within existing roadway rights of way that removes vehicular traffic lanes to create a greenway with multi-use trails and pedestrian facilities. The greenway project achieved Federal Highway Administration approval prior to the deadline of September 30, 2024. All grant funds must be expended on or before September 30, 2029.

In August 2023, and pursuant to Resolution 2023.03, the City of St. Louis and GRG received notice of additional Surface Transportation Program - Suballocated (STP-S) and the Congestion Mitigation and Air Quality (CMAQ) grant funding totaling over \$10.6 million for sidewalk and streetscape improvements opposite the greenway on the east side of Grand Blvd., enabling a complete street reconstruction. The STP-S and CMAQ programs are integral to the effort, but funding requires the greenway (RAISE) and streetscape (STP-S/CMAQ) projects to be separate and independent. The projects will be built under separate contracts. Design for the STP-S and CMAQ funds was approved by the Missouri Department of Transportation before September 30, 2024. This was one year ahead of the grant deadlines.


The design team lead by Smith Group, Inc. completed the project plans, specifications, and estimates in early 2025. Both RAISE and STP-S/CMAQ projects were released for public bid on April 3rd, and notices were published in the St. Louis Post Dispatch and the St. Louis American. The bid opportunity was also posted on the GRG website, Bid Express and via the local plan room Cross Rhodes Reprographics. A Pre-Bid meeting was held on April 10th, and a total of two addendums were issued for each project. The project included the unit price base bid and one alternate for installation of public WIFI components for greenway users. Bids were due on May 1, 2025 at 2pm CDT and at that time they were opened and publicly read aloud.

Three (3) bids were received for the RAISE project and the tabulation of results is shown above. R.V. Wagner, Inc. was the apparent low bidder. The construction management team led by Navigate Building Solutions, LLC reviewed the bid tabulations and submitted materials to ensure compliance with bid requirements and DBE goals and recommend award of the contract to R.V. Wagner, Inc. Because of the complexity of the project, GRG staff seeks Board approval of the bid amount plus a 15% contingency, for a total not to exceed contract amount of \$19,111,946.

R.V. Wagner, Inc. has submitted forms indicating their Disadvantaged Business Enterprise (DBE) participation on the project will be an estimated 22.3%. Participating DBEs in the project are to include:

- ATK Safety Supply, Inc.
- Hendersons Electric, LLC
- Site System Landscape LLC

R.V. Wagner, Inc. has worked with GRG on several recent construction projects, and GRG staff is satisfied with their performance and timeliness on projects. Because of the size of the project and GRG's fiscal cycle, construction costs are budgeted to span through 2025 and 2026. Contract expenditures within 2025 are projected to remain within the available budget. The 2026 GRG 3/16 Capital Budget will include the funds for the remaining efforts subject to Board approval. Therefore, GRG desires to authorize the contract with R.V. Wagner, Inc. and utilize funding from both fiscal years 2025 and 2026.



PROCUREMENT RESULTS DETAIL (BID RESULTS, SUMMARY OF INTERVIEWS, ETC)

A committee of staff members evaluated and scored the submittals against the criteria listed in the RFQ. The key services solicited include public engagement around art on the Brickline Greenway, developing technical Corridor Art Plans that recommend locations for various types of art, and management of the curation and commissioning of new works of art. A critical criterion for consideration was for prospective consultants to demonstrate strong project management skills and a demonstrated history of delivering high quality public art projects within established budgets and project parameters. Designing Local submitted the strongest portfolio of completed works in public settings and demonstrated the best cohort of qualified staff members needed to deliver the services required by GRG. Therefore, staff recommended the contract to be awarded to Designing Local.

WHY AND/OR HOW:

This action requests to authorize the CEO to negotiate and enter into an agreement not to exceed \$71,000, using private Foundation funds, with the Designing Local, LTD in connection with Brickline Greenway: Public Art Project Management Services in the City of St. Louis, MO.

BACKGROUND

In December 2019, Great Rivers Greenway ("GRG")'s Board of Directors approved the Chouteau Greenway (the "Brickline") Framework Plan. This project is designed to connect Forest Park, Gateway Arch National Park, Fairground Park and Tower Grove Park with more than ten (10) miles of urban greenways through many neighborhoods in the heart of St. Louis. In 2020, the Board approved changing the name of the project to Brickline Greenway. The Framework Plan presented a bold vision for the greenway as a high-level planning tool to coordinate, guide, and inform the preparation of more detailed greenway designs. Implementation of greenway project segments is to proceed at different paces, depending upon available partnerships, community engagement outcomes, previous design and planning efforts and ongoing development projects being conducted by other parties.

During the Framework process, a number of work sessions with the project's Design Oversight Committee (DOC), Universal Design Group, and other groups of stakeholders and community members took place. Six (6) aspirational strategies - design, identity, economic development, equity, public art and cultural programming - were defined to guide the Brickline Greenway overall. Integrated into the overall Design Strategy established by the framework plan, <u>Public Art was identified as an element that would</u> ensure the project is unique and grounded in the distinctiveness of St. Louis. Art can foster a look, feel, personality and soul for the greenway. It is a tool to connect communities and educate people about the cultural contributions and histories of the places they work and live. Public Art along the greenway can also serve to celebrate and unearth stories while adding a unique experience for greenway users.

In February 2022, GRG issued an RFQ for Public Art Project Management Services to assist staff in facilitating public art community engagement and to develop a Brickline Greenway Public Art Plan (the "Art Plan"). The RFQ was intended to identify an individual and/or firm that could develop a plan for public art for the Brickline through extensive public engagement, stakeholder involvement and interface with the design teams. The plan would capture the vision of the community that provides GRG and its partners with the tools needed to efficiently implement a successful and sustainable public art program. Ultimately, Via Partnership, LLP ("Via") was awarded multiple contracts to commence public art community engagement, develop the Brickline Greenway Public Art Plan and deliver three (3) Corridor Art Plans to locate discrete locations for specific art on segments that include Phase 1 of the North Connector seen in the map below. Via delivered the final Corridor Art Plans before the procurement period expired at the end of 2024.

NORTH CONNECTOR PUBLIC ART

In the North Connector Phase 1 Corridor Art Plan, (23) locations for potential art installations were identified and incorporated into the design plans recently bid for construction. Grounded in community engagement that informed the (23) locations, public art's incorporation into the greenway has robust community support, and so GRG staff explored multiple options to bring public art to fruition on the North Connector. The Brickline Greenway Art Advisory Committee (the "AAC"), comprised of stakeholders from St. Louis' premier arts organizations who are tasked with oversight and guidance of Brickline Art, recommended hiring a Public Art Project Management consultant and including a Curator on their team. Therefore, staff advertised an RFQ in March 2025 to initiate curatorial, commissioning, and installation management services. From this process, Designing Local was recommended to be the new consultant to manage the Brickline Public Art.

CONTRACT SCOPE OF WORK

Designing Local has executed more than 60 public art and arts and culture projects in over 25 states. This Board action is in connection with a new contract limited to curatorial and installation management services for the the Brickline Greenway North Connector. At a future date, staff will return to the Board to amend the contract with Designing Local to continue with development of the remaining Corridor Art Plans.

The scope of services within this limited contract will be funded by the GRG Foundation and include recruiting a public art curator for the North Connector Phase 1 project. Designing Local will present a shortlist of candidates to the AAC, who will select the final curator to begin working on the North Connector project's public art, subject to Board approved budget and funding. The Curator will also be funded by the GRG Foundation. Designing Local and its Curator will then manage the budget planning, commissioning, permitting, and installation of art works, subject to future Board approved budget. Final costs for individual art works will be determined through this process and will inform private fundraising activities to support installation of the art. This contract will be amended in the future, subject to Board consideration and approval, to continue with development of Corridor Art Plans for the remaining segments of Brickline Greenway. Staff recommends approval of this privately funded action to progress a robustly supported component of the Brickline Greenway.

WHY AND/OR HOW:

The Chain of Rocks Park construction was completed in spring 2024, and Chain of Rocks has been an actively used park since its opening. During the later stages of construction, GRG staff and users noted the portion of the Greenway adjacent to Riverview Drive was very close to the roadway edge toward the southern end of the park. Due to site and elevation restraints, the greenway had to be built along the path it currently sits. In an effort to improve user experience and feeling of safety, staff discussed multiple options with staff from Missouri Department of Transportation (MODOT) on a course of action. Both parties believe that a five (5) foot fence erected between the roadway and greenway would be an appropriate addition. This area lies within the right of way (ROW) owned by MODOT and is under its jurisdiction. The existing park improvements were constructed via a license agreement provided by MODOT to GRG for construction, operation and maintenance of the portions of the Greenway within the ROW. In order to authorize the addition of a fence, the existing license agreement needs to be amended to allow the construction of the fence and outline that GRG must own and maintain of the fence.

GRG staff are requesting that the Board of Directors authorize the CEO to negotiate and amend the existing license agreement to allow for the construction of a barrier fence between the roadway and the Mississippi Greenway at Chain of Rocks Park.

WHY AND/OR HOW:

Great Rivers Greenway (GRG) staff worked with SWT Design, Inc. and their subcontractors as well as National Park Service (NPS) staff to design a radio tower in Gateway Arch National Park after the renovations and reconfigurations made radio communication ineffective. The design was completed and advertised for bid in September 2022. Only one (1) bid was received and it was substantially over the engineer's estimate for the project. All parties felt it was best to pass on that bid and reevaluate the needs for the park.

In 2023, NPS staff reevaluated the original design and took a different approach with their radio needs. NPS approached GRG with a request to include the tower project in their 2024 request for supplemental funding and projects to be managed by GRG. Staff and NPS advertised an RFQ for professional engineering services for design and development of construction documents for a radio tower at the same location in the park as the previous design, but with a simplified design. Two (2) firms submitted a proposal, but one (1) firm did not fully understand GRG's procurement process and submitted as a design-build project. The other firm, Introba Inc. (Introba), submitted qualifications and was interviewed by GRG and NPS staff. Introba, formerly Ross & Baruzzini, Inc., was the subcontractor on the original design and is experienced in this type of work and familiar with the project and needs of the park.

GRG and NPS staff selected Introba for the design of a radio tower at the Gateway Arch National Park. After an efficient design process in which the documents were set up to attract contractors that specialize in radio tower construction, this project was advertised for bid in March 2025 and opened in April of 2025. Engineered Tower Solutions (ETS), was found to be low bid and qualified to perform the work. While its headquarters is in Raleigh, NC, its Central Division office is located in St. Peter's, MO.

GRG and NPS staff are recommending that the CEO be authorized to enter into a contract not to exceed \$341,240 with Engineered Tower Solutions for the construction of a radio tower at the Gateway Arch National Park.

WHY AND/OR HOW:

The investments made during the CityArchRiver (CAR) Project were well received by the community and region. In order to protect and maintain the investment made by the region, GRG determined that a project to investigate and develop a plan to replace components as they reach the end of their lifecycles was in order. The Gateway Arch National Park maintains a list of their own internal components, but this project aims to develop a plan that encompasses all CAR sites that GRG originally had a role in

developing. This project will not examine the Old Courthouse, the reflecting pond landscapes, or any transportation improvements.

While the exact level or size of "project" to be included in this study is not yet known, GRG and the consultant team will collectively determine this threshold as part of the process. The scale of project included in the final report will generally be \$25,000 and above.

The goals of this project include:

- Assess current conditions of key infrastructure
- Identify and prioritize needs
- Support strategic stewardship
- Enable informed planning
- Promote sustainability and public value

The deliverable of this project will be a conditions assessment report and prioritized project list with rough order-of-magnitude cost estimates that can be used to develop the CCIPA budget out to 2033. The prioritization list will be broken into 0-2 years, 3-5 years, 6-10 years, and 10+ years. The building component areas to be evaluated are HVAC, plumbing, electrical, air quality and conditioning, water distribution, exhaust systems, building envelop and roofing. The site component areas to be evaluated are playgrounds and play structures, fountains and associated water systems, specialty and landscape lighting, pavement, site amenities (seating and shade structures) and landscaping.

In their interview, George Butler Associates, Inc. (GBA) demonstrated that they have the in-house expertise and experience to fully deliver on the project goals in an efficient manner. Staff is recommending that the Board authorize the CEO to negotiate and enter in to a contract with GBA in an amount not to exceed \$75,000.

WHY AND/OR HOW:

The splash pad (Wall Fountain) sustained significant damage after an unexpected power outage that disabled our fountain alarm system and caused two pipes to freeze. Because the outage went undetected, the freeze triggered a chain of failures: the pipes from the main water line cracked and ultimately, the pumps were destroyed. In order to get the splash pad up and running this season, we need to repair the pumps and replace multiple parts of the system.

The team posted a public bid for repairs and received one (1) bid for repairs from Missouri Machinery and Engineering Co. d/b/a Hydro Dramatics and also d/b/a The Pump Shop ("Hydro Dramatics") for \$89,500. Hydro Dramatics installed the original system, has worked on maintenance throughout the life of the system and winterizes the system every year and is able to make the repairs and assist in ensuring the system is up and running as quickly as possible.
