#### WHY AND/OR HOW:

Annual Appropriation for the National Park Service Gateway Arch National Park (NPS) as required by the Supplemental Operations and Maintenance Agreement outlines a process for funding of supplemental operation and maintenance agreements (O&Ms), including the following:

- The amount of District sales tax support for net increased O&M costs is based on and limited to available annual CAR 3/16<sup>th</sup> sales tax receipts
- The District is not financially bound until such time the Board approves a funding request for net increased O&M costs
- The District and the Gateway Arch Park Foundation (GAPF) have forty-five (45) days to review, provide feedback, and obtain District and GAPF Board approvals of the annual budget for the net increased O&M costs in accordance with the policies of the District and GAPF
- Funding of net increased O&M costs may be supplemented with funds from other revenue sources
- Re-evaluation and adjustments of the net increased O&M costs will occur as part of the annual net increased O&M budget process

The Supplemental O&M Agreement did not obligate specific annual amounts for net increased O&M from the District, but instead established the processes, reporting, and approvals needed for the transfer of funding from GRG to the NPS. In addition, the District and NPS recognized that funding of net increased O&M costs may be supplemented with funds from other sources (GAPF, other partners or earned revenue, for example).

District Staff, GAPF and NPS Staff meet regularly to plan and discuss operations. These ongoing discussions allowed all parties to be prepared for submittal of the attached net increased operations and maintenance budget/request for the museum facility. The budget provided by NPS includes written explanations of each item. The NPS 2026 fiscal year begins October 1, 2025.

This budget request is for the full 2026 NPS supplemental budget request of \$888,275.64 for landscape and \$1,766,312.70 for the visitor center/ranger station facility

for a total amount of \$2,654,588.34. NPS has \$636,699.39 of unspent funds from fiscal year 2025 they have deducted from their fiscal year 2026 request and is reflected in the figures above. NPS had requested funding for projects that GRG would manage in their fiscal year 2025 request of those projects are still underway by GRG staff. These projects will be included in GRG's annual budget request to the Board of Directors in December 2025. Please see attached spreadsheets and supporting documentation for further detail. NPS has requested the supplemental budget funds be allocated in four (4) quarterly payments. These allotments are in the report and below:

October 1, 2025 - \$854,588.34

January 1, 2026 - \$600,000

April 1, 2026 - \$600,000

July 1, 2026 - \$600,000

A RESOLUTION APPROVING THE APPROPRIATION, IN ACCORDANCE WITH THE SUPPLEMENTAL OPERATIONS AND MAINTENANCE AGREEMENTS, OF AN AMOUNT NOT TO EXCEED \$2,654,588.34 TO THE NATIONAL PARK SERVICE FOR NET OPERATIONS AND MAINTENANCE INCREASE ON THE GATEWAY ARCH NATIONAL PARK IN CONNECTION WITH THE MISSISSIPPI GREENWAY AND AUTHORIZING OTHER ACTIONS AS NECESSARY TO EFFECTUATE THE SAME.

**WHEREAS**, pursuant to Resolution 2013.62, the District approved an agreement with the National Park Service which provides the process for the construction funding, operations

and maintenance funding and component part replacement costs of the Arch Grounds Projects (the "Funding Agreement");

**WHEREAS**, the Funding Agreement required the execution of a Supplemental Operation and Maintenance Agreement (the "Supplemental O&M Agreement") to address funding of Net Increased Operation and Maintenance ("O&M") Costs prior to construction bid solicitation;

**WHEREAS**, pursuant to Resolution 2014.27, the District approved the Supplemental O&M Agreement;

**WHEREAS**, the Supplemental O&M Agreement included the processes, reporting, and approvals needed for the transfer of funding from the District to the National Park Service;

WHEREAS, a second Supplemental Operations and Maintenance Agreement was executed on August 19, 2014 (the "Second Supplemental O&M Agreement, and together with the Supplemental O&M Agreement, the "Supplemental O&M Agreements"), which contained substantially the same obligations and approval processes between the National Park Service ("NPS"), the District, and Gateway Arch Park Foundation (the "Foundation");

**WHEREAS**, the Supplemental O&M Agreements establish the processes, reporting, and approvals needed for the transfer of funding from the District and/or the Foundation to the NPS and until such approvals the District and/or the Foundation are not obligated to specific funding amounts;

**WHEREAS**, the NPS has made a request for the net increased operations and maintenance of the Arch facilities (the "Net Increased O&M Costs") and has provided a budget with supporting documentation pursuant to the procedures and requirements set forth in the Supplemental O&M Agreements;

**WHEREAS**, the National Park Service is requesting \$888,275.64 for the landscape project O&M costs and \$1,766,312.70 for the Arch and ranger station O&M costs, for a total amount of \$2,654,588.34;

**WHEREAS**, the Foundation has made or will make any necessary approvals related to the Net Increased O&M Costs as may be required by the Supplemental O&M Agreements;

**WHEREAS**, the District desires to authorize the Chief Executive Officer to (i) appropriate funds necessary to fund the Net Increased O&M Costs; (ii) deposit such funds into the

dedicated accounts set forth under the Supplemental O&M Agreements; and (iii) take any actions necessary or appropriate to effectuate the same; and

**WHEREAS**, at a meeting of the Board of Directors of the District (the "Board"), convened at 11:30 pm, on September 9, 2025, at the District Offices at 3745 Foundry Way, Suite 253, St. Louis, Missouri, at which was present a quorum of the Board, the Board took the action further described herein.

# NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE METROPOLITAN PARK AND RECREATION DISTRICT D/B/A THE GREAT RIVERS GREENWAY DISTRICT AS FOLLOWS:

- 1. The Board hereby approves the Net Increased O&M Costs submitted by the National Park Service.
- 2. # PROCUREMENT RESULTS DETAIL (BID RESULTS, SUMMARY OF INTERVIEWS, ETC)

This is a contract amendment. Originally, an RFQ was advertised for this project. One (1) firm submitted qualifications and two (2) other firms indicated they would have submitted but declined because if they were selected would subsequently be excluded from bidding on the construction.

The firm that submitted a response, Introba, Inc., was interviewed. They demonstrated that they are well qualified with their in-house security group which also has ample capacity to perform the work. Introba, Inc. has completed the initial scope of work and this is an amendment to add services from bidding through project closeout.

**WHEREAS**, the Metropolitan Park and Recreation District d/b/a The Great Rivers Greenway District (the "District") is a metropolitan park and recreation district authorized under Section 67.1700 to 67.1769 of the Revised Statutes of Missouri, as amended (the "District Act");

**WHEREAS**, pursuant to the Clean Water, Safe Parks, and Community Trails Initiative ("Proposition C"), the qualified voters of St. Louis County, St. Charles County, and St. Louis City approved the creation of the District;

**WHEREAS**, the District was formed to undertake the development, operation and maintenance of a public system of interconnecting trails and parks throughout the areas and counties comprising the District (the "District's Mission");

the purpose of funding the operation and maintenance of the portion of the District located within St. Louis City and St. Louis County;

# WHY AND/OR HOW:

This action requests to authorize the CEO to negotiate and enter into a contract with Raineri Construction, LLC in an amount not to exceed \$1,905,267 for the construction of the Hodiamont Greenway: Gwen Giles Park Trailhead in the City of St. Louis (City). The total requested amount also includes a 10% contingency.

In August 2024, the GRG Board approved Resolution 2024.72, which is a cooperation and funding agreement with the Cornerstone Community Development Corporation which received \$277,500 in grant funding using ARPA funds from the St. Louis Development Corporation for the design and construction of the Hodiamont Greenway: Gwen Giles Park and Trailhead improvements. \$170,000 of the \$277,500 will be used for the construction of these contracted improvements.

The Hodiamont Greenway on the Hodiamont Tracks is a project GRG has been working on for several years and this segment is the first one to move into final design and now construction. Converting the former Hodiamont "Suburban Tracks" streetcar line into a 3.4-mile greenway from the Grand Center Arts District on the east to Gwen Giles Park on the west, linking seven (7) city neighborhoods, including Covenant Blu Grand Center, Vandeventer, Lewis Place, Fountain Park, Academy-Sherman Park, Visitation Park, and West End. GRG anticipates utilizing City street rights-of-way along Enright Avenue, from Pamoja Academy to Spring Avenue where the Hodiamont will intersect with the proposed Brickline Greenway. (See map below).

Five (5) bids were received by the solicitation deadline of August 12th, 2025. Details on the bids are noted above, and GRG staff and our construction management team were pleased with the bids submitted during this highly busy time for construction contractors. All five (5) bids received were within close range to our construction estimate provided by our Construction Management firm, Navigate Building Solutions. Bid selection was informed by the Base bid plus the accepted alternate. Alternative 1 is an option for lighting and auxiliary power incorporated into the Pavilion structure.


After a comprehensive review by Navigate Building Solutions and GRG staff, Raineri Construction, LLC was determined to be the lowest and best bidder. Raineri Construction, LLC has completed many projects with GRG over the years and was the City of St. Louis construction contractor on the recently completed Brickline Greenway segment at Energizer Park Stadium in 2023.

Staff from Navigate Building Solutions and DTLS reviewed Raineri Construction, LLC bid tabulations and submitted materials to ensure compliance with bid requirements. Bid day results and subcontractor details, including participation of minority and womenowned businesses, were analyzed after submission of materials which features 6.37%

Minority-Owned Business Enterprises (MBE) and 47.43% Woman-Owned Business Enterprises (WBE).

GRG staff is including a 10% construction contingency. GRG staff seek approval for the Raineri Construction, LLC contract amount, plus a 10% contingency for a total not to exceed the amount of \$1,905,267, subject to future appropriation. The available 2025 Capital Budget includes \$486,102 and costs will be kept within budget for the reminder of the year. The balance of construction will take place in 2026 and will be included in the 2026 GRG 3/16th Capital Budget (288C) pending Board approval.

Construction is estimated to begin in October 2025 and continue through the Fall of 2026.

# **WHY AND/OR HOW:**

This action requests to authorize the CEO to enter into a construction contract with McGrath and Associates, Inc. not to exceed \$358,637 in connection with

construction services for the Centennial Greenway: Creve Coeur Park to Katy Trail Signage Betterment in St. Louis and St. Charles Counties.

#### PROJECT INFORMATION

This project will update approximately forty-five (45) wayfinding and interpretive signs to create a better user greenway experience, with clear navigation, traveling between the St. Louis County's Creve Coeur Park, the KATY Trail, and the Fee Fee and Centennial Greenways (see map below). Approximately 9.5 miles of trail would be reviewed as part of this project (the yellow highlighted trails on the map). This project was originally planned for the 2020 Capital Budget but was placed on hold till 2022 due to the Covid-19 pandemic and reduced revenue projections. This project will greatly assist park and greenway users on the various trails within Creve Coeur Park and visitors along the KATY Trail accessing the GRG greenway system. The project goals are:

- Upgrade signage and brand graphics to ensure an excellent experience where
  users can navigate easily between the Centennial and Fee Fee Greenways, KATY
  Trail, and the amenities at Creve Coeur Park. Improve the wayfinding system using
  signage to denote the various trails within Creve Coeur Park which is very
  confusing to non-regular park and trail users.
- Identify art and environmental graphics opportunities working with GRG and St. Louis County Park staff.
- Improve the wayfinding system, maps, locations or other signs, remove sign clutter and enhance user experience.

The design team composed of Horner and Shifrin and Reichmann Consulting, LLC completed the project plans, specifications, and estimates in early 2025. Project was released for public bid on June 5, 2025, and notices were published in the St. Louis Post Dispatch and the St. Louis American. The bid opportunity was also posted on the GRG website, Bid Express and via the local plan room Cross Rhodes Reprographics. A Pre-Bid meeting was held on June 24, 2025, and one addendum was posted on July 1, 2025. The project included the unit price base bid and one (1) alternate bid item to provide and install two kiosks. Bids were due on July 17, 2025, at 3:30pm CDT and at that time they were opened and publicly read aloud.

Five (5) bids were received for the project, and the tabulation of results is shown above. The bids from Swans Construction LLC and The Harlan Company were rejected for irregularities in their bids for not using the updated bid form provided in Addendum

1. The construction management team led by Horner & Shifrin, Inc., reviewed the bid

tabulations and submitted materials to ensure compliance with bid requirements and recommended award of the contract to McGrath and Associates, Inc. GRG staff recommends to include the one (1) alternate. And given the complexity of the various sign types, various agencies and potential unforeseen conditions, GRG staff recommends a 16.2% construction contingency for a total not to exceed contract amount of \$358,637.

Construction costs are budgeted to span through 2025 and 2026. Contract expenditures within 2025 are projected to remain within the available 2025 budget. The 2026 GRG 3/16 Capital Budget will include the funds for the remaining construction efforts subject to Board approval. Therefore, GRG desires to authorize the contract with McGrath and Associates, Inc. and utilize funding from both fiscal years 2025 and 2026.

#### WHY AND/OR HOW:

This Board Action requests to authorize the CEO to enter into a Construction Contract with Vision Civil Construction, LLC ("Vision") in connection with Deer Creek Greenway: Oxford Bend Park in the City of Webster Groves.

This project will enhance the parcel acquired by GRG in 2019 at the south-west corner of the Big Bend Blvd and Oxford Road intersection. This parcel will be transformed to a beautiful park that will include the connection from the existing Deer Creek Greenway termini in the City of Maplewood and connect to the future segment to the River des Peres Greenway in the City of St. Louis. This is a missing gap on the system that will connect over 30 miles of greenway through the Deer Creek, River des Peres and Gravois Greenways. In addition to the greenway connection, this park will include a nature playground, an expanded path with skateable features, a pavilion and patio with tables and chairs, bike fix it station, bike parking area, an enhance woodland edge by the Deer Creek, and additional amenities such as screening mounds and fencing.

The design team composed by M3 Engineering, Oates and Associates and DTLS Landscape Architects, completed the project plans, specifications, and estimates in early 2025. The project was released for public bid on July 10th, and notices were published in the St. Louis Post Dispatch and the St. Louis American. The bid opportunity was also posted on the GRG website, Bid Express and via the local plan room, Cross Rhodes Reprographics. A Pre-Bid meeting was held on July 24th, and no addendums were issued for the project. The project included the unit price base bid and six (6) alternate bid items including solar powered lighting, water connection for a water fountain, and additional pavers, fencing and tree pruning. Bids were due on August 7, 2025 at 3:30pm CDT and at that time they were opened and publicly read aloud.

Four (4) bids were received for the project. The construction management team, led by GFT, reviewed the bids and determined that one bid (submitted by Byrnes & Jones) was irregular and was therefore rejected. GFT determined that, of the remaining three (3) bids, Vision was the lowest and recommended that the contract be awarded to Vision. The City of Webster Groves and GRG staff discussed the alternate bid items, and it was agreed to award Alternates 1, 2, 4 and 5. Excluding Alternate 3 - Tree Prunning, which the City has committed to do in-house, and Alternate 6 - Unit Paving, which was added to measure the cost of adding pavers versus regular concrete on the patio area. Therefore, GRG staff seeks Board approval of the bid amount including four (4) alternates plus a 10% contingency, for a total not to exceed contract amount of \$1,296,900. The City of Webster Groves wlll provide \$150,000 towards the construction of the project.

GRG requested references and spoke to the following, all of whom indicated they were pleased with performance and would hire Vision for future work: City of Wentzville, St. Charles County Highway Department, Rockwood School District, and City of Lake St. Louis. As such, GRG is comfortable recommending Vision to complete the work for this project.

Construction costs are budgeted to span through 2025 and 2026. Contract expenditures within 2025 are projected to remain within the available budget. The 2026 GRG 3/16 Capital Budget will include the funds for the remaining efforts subject to Board approval. Therefore, GRG desires to authorize the contract with Vision and utilize funding from both fiscal years 2025 and 2026.

#### WHY AND/OR HOW:

This Board Action is to approve a contract for \$235,000, subject to future appropriation, with Navigate Building Solutions, LLC, for pre-construction and construction management services for the Centennial Greenway segment from Olive Blvd to Dielman Road in the City of Olivette.

Extending the Centennial Greenway from the existing 1.3-mile segment between Warson Road and Dielman Road to the west, and from Olive Blvd and I-170 to Shaw Park to the east, has been a priority since this is the last segment creating a gap in the alignment identified in 2018. Connecting these two segments will provide improved connectivity for greenway users to adjacent businesses and residential areas, as well as creating a continuous greenway of more than 4.5 miles from Shaw Park in the City of Clayton to Warson Road, with eventual expansion westward towards Creve Coeur Memorial Park.

Pursuant to Resolution 2020.59, The WSP USA INC. team (WSP) initiated data collection and concept design for this project within the City of Olivette. WSP's efforts were critical in developing multiple other segments of the Centennial Greenway from Warson Road through the new Five Oaks on Warson/Warson Park, connecting now to Indian Meadows

Park to Dielman Road. Additionally, the Olive Blvd and I-170 intersection was completed with safety improvements and a wall mural under the highway bridge with GRG branding.

Since the early planning and design phase, the Union Pacific railroad corridor (labeled as 599B in the map below) was identified as the best location for the greenway. In November of 2024, GRG was successful in acquiring the railroad corridor which is currently under design. This summer, WSP has completed 70% design of the segment between Dielman Road and Olive Blvd and continues to advance the design pending the acquisition of additional easements necessary to connect the segment along the railroad corridor to Dielman Road. As the project is now 70% designed, it is time to bring a construction management firm to the team to help with final preparation of the design plans and preconstruction services and preparing for a public bid in 2026.

In June 2025, Great Rivers Greenway (GRG) staff released a Request for Qualifications (RFQ) for pre-construction and construction management services across multiple greenway projects including Centennial Greenway (599B). The RFQ was published in the St. Louis Post-Dispatch, the St. Louis American newspapers, the GRG website and was announced via an email to GRG's jobs and bids electronic database. Six (6) responses were received that expressed interest in the services advertised for the Centennial Greenway project. A selection committee composed of GRG and City of Olivette staff evaluated the proposals.

Three (3) firms which applied for the Centennial Greenway projects were interviewed in August: Navigate Building Solutions, BSI and Shannon & Wilson. The selection committee recommended Navigate Building Solutions, LLC (Navigate) as the best qualified and capable firm to perform the services outlined in the RFQ for this project. The Navigate team includes the St. Louis firm Engineering Design Source, Inc. (EDSI) (MBE) and TSI Geotechnical, Inc. (M/WBE) which will perform survey and material testing respectively. Navigate was previously selected by the City of Olivette to serve as its construction manager for the construction of the Community Center and multiple parks and greenway improvements within the City. Navigate brings extensive knowledge due to their work within Warson Park and Indian Meadows Park and Navigate understands the City's expectations for the coordination between GRG, City staff, adjacent property owners, and the various utilities and other agencies for the greenway construction. GRG staff appreciates the City's desire for seamless construction coordination. Navigate has proven to be an excellent team player and a very successful construction manager in past GRG greenway construction projects.

This contract with Navigate includes 9 months of pre-construction services for project. Also included are construction management services for 12 months for the construction phase of the project. The not to exceed fee is established at \$235,000 for the contract. The value of M/WBE contracts in the scope totals 10%.

The Navigate team services include:

- Pre-construction services including plan review and bidding services
- Cost estimation services
- Full-time on-site construction supervision for 12 months
- Business enterprise tracking for women and minority owned companies
- Material testing and inspection services

The 2025 budget for the (599B) project included \$433,038 and contract expenditures within 2025 are projected to remain within the available budget. Future GRG 1/10 Capital Budgets will include the funds for the remaining efforts subject to Board approval.

PROCUREMENT RESULTS DETAIL (BID RESULTS, SUMMARY OF INTERVIEWS, ETC)

In June 2025, Great Rivers Greenway (GRG) staff released a Request for Qualifications (RFQ) for pre-construction and construction management services across multiple greenway projects including Meramec Greenway (247A). The RFQ was published in the St. Louis Post-Dispatch, St. Louis American, the GRG Website, and was announced via an email to GRG's jobs and bids electronic database. Five (5) responses were received that expressed interest in the services advertised for the Meramec Greenway project. A selection committee composed of staff from GRG, St. Louis County and DG2 Design, LLC evaluated the proposals. Three (3) firms were interviewed on August 14, 2025: Shannon & Wilson, Gonzalez Companies, and Kozeny-Wagner. The interviews considered all criteria outlined in our solicitation. Shannon & Wilson and Kozeny-Wagner made presentations using power point. Gonzalez Companies did not have a presentation. All firms stated they would meet our minority and women business enterprise goals. The selection committee recommended Kozeny-Wagner based on their relevant experience, community engagement and familiarity with the project area.

#### WHY AND/OR HOW:

This board action is to approve a contract for \$978,200, subject to future appropriation, with Kozeny-Wagner, Inc. for pre-construction and construction management services for the Meramec Greenway segment in Unger County Park in St. Louis County.

This project includes the Meramec Greenway segment in Unger County Park that has experienced extensive flooding damage. This project develops a trail alignment that relocates the existing trail to avoid repeated flood damage. DG2 Design LLC completed a planning study that the GRG Board authorized under Resolution 2022.51 approving a contract not to exceed \$206,140 (Original Contract) which shifts the trail alignment within Unger County Park and identifies recommended improvements and new greenway trail that will benefit greenway and park users connecting to the I-44 Meramec River Bike and Pedestrian Bridge and the greenway south to the City of Fenton.

In September 2023, the Board authorized Resolution 2023.70 approving a contract amendment not to exceed \$938,000 with DG2 Design, LLC to complete 100% design of the project. In addition, the project consultant team completed a technical feasibility

report for a bicycle/pedestrian bridge across the Meramec River from Unger Park to the existing Meramec Greenway in Greentree Park located north of the river in the City of Kirkwood. The previous planning study identified two locations within Unger Park for additional technical feasibility in order to determine the viability of a bicycle/pedestrian bridge. The technical report determined that a bridge across the Meramec is feasible to meet the "no rise" requirement along the Meramec River. A separate project (247B Meramec Greenway: Bridge from Unger Park to Greentree Park) was approved by the Board for the 2025 Capital Budget to continue this investigation and analysis.

In June 2025, Great Rivers Greenway (GRG) staff released a Request for Qualifications (RFQ) for pre-construction and construction management services across multiple greenway projects including Meramec Greenway (247A). The RFQ was published in the St. Louis Post-Dispatch, St. Louis American, the GRG Website, and was announced via an email to GRG's jobs and bids electronic database. Five (5) responses were received that expressed interest in the services advertised for the Meramec Greenway project. A selection committee composed of staff from GRG, St. Louis County and DG2 Design, LLC evaluated the proposals.

Three (3) firms which applied for the Meramec Greenway project were interviewed in August: Shannon & Wilson, Gonzalez Companies, and Kozeny-Wagner. After the interviews, the interview team discussed all strengths and weaknesses of the three firms and recommended Kozeny-Wagner, Inc. due to their significant experience relevant to the project and their attention to detail related to community engagement and worksite communication with the public. In addition, Kozeny-Wagner, Inc. has experience working with the project partners and working in particular with both Burlington Northern Santa Fe and Burlington Junction Railways which have an abandoned rail spur at Cassens Drive and GRG and St. Louis County are working to provide a new trail connection for adjacent businesses to access the greenway and park.

The contract with Kozeny-Wagner, Inc. includes 8 months of pre-construction services for the project. Also included are construction management services for 14 months of the construction project. The not to exceed fee is established at \$978,200.

The Kozeny-Wagner team includes ABNA Engineering, Inc. (M/WBE) which will be handling the Material Testing and inspection services. The complete services includes the following:

- Pre-construction services including plan review and bidding services
- Cost estimation services

- Full-time on-site construction supervision for 14 months
- Business enterprise tracking for women and minority owned companies
- Material testing and inspection services (ABNA Engineering, Inc.)

The 2025 budget for the (247A) project included \$875,000 for Pre-Construction and Construction Management Services. Contract expenditures within 2025 are projected to remain within the available 2025 budget. Future GRG 1/10 Capital Budgets in 2026 and 2027 will include funds for the remaining efforts subject to Board approval.

**WHEREAS**, at a meeting of the Board, convened at 11:30 am, on September 9, 2025, at the District Offices at 3745 Foundry Way, St. Louis, Missouri, at which was present a quorum of the Board, the Board took the action further described herein.

#### **WHY AND/OR HOW:**

At its November 12, 2024 Board of Directors meeting, the District Board approved a Cooperation Agreement with St. Louis County wherein the District agrees to take on the cost of construction (including construction management) for improvements to three (3) heavily utilized County bridges on Gravois Greenway. By way of background, the County had previously agreed to pay for construction while the District paid for design, but budget constraints caused the County to indefinitely postpone the projects.

The most critical component of the project is the replacement of the existing wooden bridge which continues to deteriorate and approach the need for closure. While all three (3) of these structures could be completed separately, given economies of scale and the

need for greenway closures and detours, staff are recommending all three (3) structures be repaired or replaced at the same time. Total construction for all three (3) is estimated to be ninety (90) days, which will require a detour around the structures through Officer Blake Snyder County Park for that entire time. St. Louis County Parks staff would support the project through design review and coordination with other STLC departments to obtain necessary permits and authorization.

Throughout 2025 the project plans were finalized and submitted for permit. Once permits were granted by St. Louis County, City of Green Park, and MSD, this project was advertised for public bid. The construction estimate prepared by TWM, Inc, was \$836,725.42 including contingency. The project had six (6) responsive bidders that were tightly bunched, indicating competitive bids. Pace Construction was low bid at \$957,000. An analysis of the estimate versus the bids was completed by TWM Inc., ABNA (construction manager) and GRG. TWM indicated that six-months ago their estimates were within 1% of actual bids, but within the past two weeks they've had several projects where bids came in very high like this one. This could indicate a shift in the market that has not yet been accounted for in their estimating tools.

Pace's bid was validated and they have previous experience with bridge replacements on Gravois Greenway where they performed well. The closure of the greenway and construction is scheduled to begin on December 1, 2025 and Pace indicated that the 90-day closure limit was achievable.

Its is staff's recommendation that the board approve this construction contract with Pace in an amount not to exceed \$1,052,700 which includes 10% for GRG-held contingency.
