

#### WHY AND/OR HOW:

Great Rivers Greenway (GRG) has been providing supplemental security and monitoring on greenways since 2014. This has come in several different forms including: police officers, guides and security guards. When Kiener Plaza was reopened and GRG assumed operations and maintenance of the park, a full-time security guard was deployed initially for sixteen (16) hours a day and then for twenty-four (24) hours a day one (1) year later. Additionally, bike-mounted security guards have been utilized to provide supplemental monitoring and oversight on the St. Vincent, River des Peres and Mississippi Greenways. When Katherine Ward Burg Garden opened in early 2023, rather than employ on-site security, the park was observed remotely by guards at Kiener Plaza. Additionally, GRG has agreed to provide a security guard on the Mississippi Greenway: Leonor K. Sullivan (LKS) at the Chouteau Avenue guard house at the newly constructed gates. Due to construction delays and damage to the City's electrical infrastructure, that guard was not utilized in 2024 but provided services in a reduced capacity in 2025.

In 2023, GRG solicited and received 10 bids for supplemental security services for 2024-2028. After a thorough evaluation, GRG staff recommended, and the Board approved, an initial contract for \$735,000 with Whelan Security Company d/b/a GardaWorld Security Services (GardaWorld). In 2025, GRG included overnight staffing at the guard booth at Chouteau Avenue on LKS and overnight/off-site camera monitoring at Katherine Ward Burg Garden and Chain of Rocks Park. The 2025 contract value was \$727,000. For 2026, a rate increase will be necessary to sustain the same level of monitoring, resulting in

a proposed 2026 contract value to \$785,437. This includes a 5% contingency for on-call response, as did the contract in 2025.

GRG staff are recommending that the Board of Directors authorize the CEO to negotiate and renew the contract with GardaWorld to provide security at Kiener Plaza, Chain of Rocks Park, Katherine Ward Burg Garden and on the Mississippi, River des Peres and St. Vincent Greenways for 2026. These services would be for a combination of staffed security, remote monitoring, bike-mounted patrols and on-call response to incidents.

**WHEREAS**, the Metropolitan Park and Recreation District d/b/a The Great Rivers Greenway District (the "District") is a metropolitan park and recreation district authorized under Section 67.1700 to 67.1769 of the Revised Statutes of Missouri, as amended (the "District Act");

**WHEREAS**, pursuant to the Clean Water, Safe Parks, and Community Trails Initiative ("Proposition C"), the qualified voters of St. Louis County, St. Charles County, and St. Louis City approved the creation of the District;

**WHEREAS**, the District was formed to undertake the development, operation and maintenance of a public system of interconnecting trails and parks throughout the areas and counties comprising the District (the "District's Mission");

**WHEREAS**, in furtherance of the District's Mission, and in accordance with the Bylaws of the District, the District adopted "Building the River Ring" as the Regional Plan for the District, and which contains the comprehensive plan of the District, its existing and proposed interconnecting greenway, park and trail projects, and any proposed land acquisitions (the "River Ring Regional Plan");

**WHEREAS**, all Greenways are shown as a regional greenway in the River Ring Regional Plan (the "Greenway");

**WHEREAS**, the District desires to improve the River Ring in furtherance of the River Ring Regional Plan by providing supplemental greenway monitoring and security (the "Project");

**WHEREAS**, pursuant to the approval of Proposition C and Section 67.1712.1 of the District Act, the governing bodies of St. Louis County, St. Charles County, and St. Louis City imposed a one-tenth of one cent sales tax for the purpose of funding the creation, operation and maintenance of the District;

**WHEREAS**, pursuant to the approval of the Safe and Accessible Arch and Public Parks Initiative ("Proposition P") and Section 67.1712.2 of the District Act, the governing bodies of St. Louis City and St. Louis County imposed a three-sixteenths of one cent sales tax for the purpose of funding the operation and maintenance of the portion of the District located within St. Louis City and St. Louis County;

**WHEREAS**, the 2025 GRG 1/10 Capital Budget and the 2025 CAR 3/16 Capital Budget were approved by the District pursuant to Resolution 2024.107 and Resolution 2024.108 respectively;

**WHEREAS**, the 2025 GRG 1/10 Capital Budget and the 2025 CAR 3/16 Capital Budget included line items (762), (799) and (881) for the Project;

**WHEREAS**, the 2026 GRG 1/10 Capital Budget will include line items (762), (799) and (881) for the Project;

**WHEREAS**, pursuant to Resolution 2023.85, the District authorized the Chief Executive Officer to negotiate and enter into a contract with Whelan Security Company d/b/a

GardaWorld Security Services, Inc. for monitoring and security services in furtherance of the Project, and the District subsequently entered into a contract with Whelan Security Company d/b/a GardaWorld Security Services;

**WHEREAS**, the District desires to (i) enter into a contract renewal with Whelan Security Company d/b/a GardaWorld Security Services, Inc., and (ii) amend the period of service and compensation under the existing contract;

**WHEREAS**, the District desires to (i) authorize the Chief Executive Officer to negotiate and enter into a contract renewal with Whelan Security Company d/b/a GardaWorld Security Services, Inc.; and (ii) take any actions necessary or appropriate to effectuate the same; and



#### WHY AND/OR HOW:

Great Rivers Greenway (GRG) has either primary maintenance responsibility or supplements the care of certain greenways throughout St. Louis City, St. Louis County and St. Charles County. In October 2023, GRG staff conducted a public request for bids for these services as well as for as-needed maintenance tasks not associated with an active project or greenway. Bids were requested for an initial one-year contract term with two (2) one-year renewals.

Seven (7) firms submitted sealed bids for the individual greenway segments or scopes of work (including hourly labor rates) for as-needed services based on an average of 2000 hours annually for work that is not a part of their normal scope of work (i.e., vandalism, car accidents, weather related incidents, as well as special projects that arise throughout the year). The Board of Directors authorized the CEO to enter into a contract with

TRC Outdoor LC (TRC) for their initial contract for 2024 and then authorized the CEO a renewal contract for its second year in 2025.

GRG staff recommends an additional renewal of the comprehensive greenway maintenance contract with TRC for 2026. Below are the greenway projects included in 2026, with some areas enhanced due to landscaping installed in 2025. A 3% increase is included across all sites with the addition of a few sites post construction.

The portion of TRC's scope for subproject 732 (total of \$707,236.26) from the GRG 1/10th includes the following greenways:

- Mississippi Greenway: Katherine Ward Burg Garden to Chain of Rocks Park
- River des Peres Greenway: Carondelet Connector, Raingarden Maintenance and Esplanade to Manhattan
- St. Vincent Greenway: Forest Park to St. Vincent County Park
- Centennial Greenway: Warson Park & Indian Meadows Park
- Busch Greenway: Raingarden quarterly maintenance
- Gravois Greenway: Mysun Trailhead to Germania
- Regional: As-needed services

#### **WHY AND/OR HOW:**

This action requests to authorize the CEO to negotiate and enter into a Cost Apportionment Agreement not to exceed \$339,000, subject to future appropriation, with MoDOT in connection with design costs associated with Brickline Greenway: Compton Avenue to Grand Boulevard in the City of St. Louis, MO.

#### BACKGROUND

In December 2019, Great Rivers Greenway ("GRG")'s Board of Directors approved the Chouteau Greenway (the "Brickline") Framework Plan. This project is designed to connect Forest Park, Gateway Arch National Park, Fairground Park and Tower Grove Park with more than ten (10) miles of urban greenways through many neighborhoods in the heart of St. Louis. In 2020, the Board approved changing the name of the project to Brickline Greenway.

During the Framework process, a network of segments to advance toward construction was identified to achieve the critical connections between Tower Grove Park, Fairground Park, Forest Park, and Gateway Arch National Park. Moving east to west, the central corridor included an alignment between the Cortex Metrolink Station at Sarah Street and the Grand Metrolink Station at Grand Boulevard. GRG staff successfully applied for federal Congestion, Mitigation, and Air Quality ("CMAQ") grant funding through East-West Gateway Council of Governments, and the project advanced to final design in 2025. Unfortunately, significant challenges to clearing right-of-way ("ROW") proved insurmountable within the timeline constraints presented by the CMAQ program, and ultimately, GRG made the decision to postpone that project's construction until necessary ROW can be fully obtained. Therefore, staff recommends a separate east-west route, detailed below, to complete the central corridor of the Brickline Greenway.

#### DETAILS ABOUT THIS BOARD ACTION

In partnership with the Federal Highway Administration, City of St. Louis, Bi-State Development Agency, Great Rivers Greenway, and East-West Gateway Council of Governments, MoDOT conducted a Planning and Environmental Linkages study ("Future64") study to understand how Interstate 64 ("I-64"), transit, bicycle and pedestrian infrastructure, and the surrounding street network can be re-envisioned to serve community needs better. The study area stretched from Jefferson Avenue on the east, to Kingshighway on the west, to Forest Park Avenue on the north and to Chouteau Avenue on the south. The final study, completed in 2023, documents the transportation issues and environmental concerns in the I-64 corridor and provides project recommendations for future development consideration.

In summer of 2025, MoDOT notified GRG staff that it had secured funding to reconstruct the east interchange area comprising I-64 and its network of on- and off-ramps between Grand Boulevard and Compton Avenue (see the area labeled as "Project 4" in the attached map graphic). Included within the project scope is a new proposed network of 10-foot shared-use paths on Forest Park Avenue, Theresa Avenue, Bernard Street, and Spruce Street. Therefore, the work proposed by MoDOT presents a timely opportunity to partner in the design and construction of the segment on Forest Park Avenue to deliver Brickline Greenway improvements between Compton Avenue and Grand Boulevard. The improvements would include widening the 10-foot pathway to meet Brickline Greenway design standards. This segment connects to the stretch of greenway on Market Street at Harris-Stowe State University that is currently under construction and establishes a new east-west linkage through the central corridor of the Brickline Greenway. In the future, the Brickline will continue westward from Grand Boulevard on Forest Park Avenue toward the Foundry development and Vandeventer Avenue.

The not to exceed cost of \$339,000 associated with this action funds design work by MoDOT's consultant, by way of a cost apportionment agreement, to develop final design plans for the Brickline Greenway improvements on Forest Park Avenue, with construction anticipated in 2027. Once final construction costs are estimated in late 2026, staff will return to the Board for a supplemental cost apportionment agreement with MoDOT in connection with the cost of construction for the additional Brickline trail width and amenities. MoDOT will serve as the Construction Owner and will procure the construction contractor to construct this section of Brickline Greenway as part of the greater east interchange construction project.

Staff recommends approval of this action due to the efficiencies captured by GRG through the partnership. MoDOT has agreed to fund the cost of its already proposed shared-use path network, including the baseline 10-foot concrete path on Forest Park Avenue, which represents a significant cost saving to GRG. GRG's funding contribution will be used to upgrade MoDOT's proposed path up to Brickline Greenway Design Guideline standards.

The federal funds are for the construction of streetscape improvements on Spring Avenue between Laclede Avenue and Forest Park Avenue to complement the Brickline Greenway Midtown I-64 Crossing project (308K). The TAP project will reconstruct two (2) blocks of sidewalk and intersection crossings on the opposite side of Spring Avenue from the Brickline Greenway improvements. The effort to extend the Brickline Greenway from Saint Louis University to the Grand MetroLink Station (308K) has been underway since 2021 and the project area was awarded \$9.9 million in federal discretionary funding through the Reconnecting Communities Pilot grant.

The application was ultimately successful and the project was recommended for funding by East-West Gateway Council of Governments Board of Directors. The Program Agreement will secure these federal funds for use in the construction of the streetscape improvements for the Brickline Greenway segment, providing \$1,572,700 (or more) of the total estimated \$2,500,000 construction cost. The local matching funds will need to be allocated in GRG's future budgets to ensure GRG meets its local matching requirements under the TAP Grant. Private sources of funding can be applied to the local match as well.

Per GRG's procurement policy, a Request for Proposals was advertised in June 2025 for pre-construction and construction management services across multiple greenway projects. Five firms provided submittals which indicated interest in the advertised services for the Brickline Greenway Midtown I64 Crossing project. The five (5) firms indicating interest included: ABNA Engineering, Inc., BSI Constructors, Inc., Gonzalez Companies, LLC., Kozeny Wagner, Inc., and Navigate Building Solutions, LLC. Based on the proposals submitted, three firms were selected for interviews. The firms were: BSI Constructors, Inc., Gonzalez Companies, LLC., Kozeny Wagner, Inc. A selection committee composed of staff from both GRG and the Missouri Department of Transportation (MoDOT) conducted online interviews on September 11, 2025. The Kozeny Wagner, Inc. team was the unanimous recommendation from the selection committee.

#### WHY AND/OR HOW:

This Board Resolution will enable GRG to execute a contract with Kozeny Wagner, Inc. for pre-construction services for the Brickline Greenway: Midtown I-64 Project. The project was awarded over \$9.9 million from the U. S. Department of Transportation (USDOT) Reconnecting Communities Pilot (RCP) Discretionary Grant in March 2024.

The Brickline Greenway Framework Plan includes a concept for a pedestrian and bicycle crossing of I-64 within the Midtown neighborhood of St. Louis. The project lies at the central crossroads of the Brickline Greenway near the City Foundry STL and Armory District developments, Saint Louis University, Saint Louis University Medical Campus and the Grand MetroLink station (308K), as shown on the image below. Pursuant to Resolution 2023.73, GRG applied for and was awarded over \$9.9 million in USDOT RCP Discretionary Grant Program funding in support of construction for the project. GRG staff began negotiating the grant agreement under the guidance of staff from the Missouri Division of USDOT Federal Highway Administration (FHWA). Grant agreement progress was temporarily paused following actions by the current federal administration; however, this temporary pause has ended. Missouri Division of FHWA staff indicate that agreement review is progressing.

Kozeny Wagner, Inc., was procured as a result of a Request for Proposals (RFP) issued in June 2025. The RFP sought pre-construction and construction management services across multiple greenways including the Brickline Greenway Midtown I-64 Crossing project. Five firms submitted a proposal for the project and on September 11, 2025 virtual interviews were conducted with three firms as noted above. The selection committee composed of staff from both GRG and MoDOT unanimously recommended Kozeny Wagner, Inc.

Kozeny Wagner, Inc. has developed a scope and fee for project pre-construction services. The not to exceed fee is established at \$75,430.

Pre-Construction services include but are not limited to:

- Pre-construction services:
  - Cost estimation
  - Scheduling
  - Plan review

This represents the pre-construction phase for the project. An additional contract amendment for construction management services is expected to occur in 2026-2027. The goal is to construct the project concurrently with MoDOT's reconstruction and rehabilitation of I-64 currently planned for 2027-2028.

The 2025 budget for the (308K) project includes \$759,720. Contract expenditures within 2025 are projected to remain within the available budget. Future GRG 3/16 Capital Budgets will include the funds for the remaining efforts subject to Board approval. Therefore, GRG desires to authorize the contract with Kozeny Wagner, Inc. and utilize funding from both fiscal years 2025 and 2026.

**WHEREAS**, the District was formed to undertake the development, operation and maintenance of a public system of interconnecting trails and parks throughout the areas and counties comprising the District (the "District's Mission");

**WHEREAS**, in furtherance of the District's Mission, and in accordance with the Bylaws of the District, the District adopted "Building the River Ring" as the Regional Plan for the District, and which contains the comprehensive plan of the District, its existing and proposed interconnecting greenway, park and trail projects, and any proposed land acquisitions (the "River Ring Regional Plan");

**WHEREAS**, pursuant to the approval of the Safe and Accessible Arch and Public Parks Initiative ("Proposition P") and Section 67.1712.2 of the District Act, the governing bodies of St. Louis City and St. Louis County imposed a three-sixteenths of one cent sales tax for the purpose of funding the operation and maintenance of the portion of the District located within St. Louis City and St. Louis County;

**WHEREAS**, the Brickline is shown as a regional greenway in the River Ring Regional Plan (the "Brickline Greenway");

**WHEREAS**, the District desires to extend and improve the River Ring in furtherance of the River Ring Regional Plan by extending the Brickline Greenway at Midtown I-64, Laclede Avenue to Grand MetroLink Station (the "Project");

**WHEREAS**, the 2025 GRG 3/16 Capital Budget was approved by the District pursuant to Resolution 2024.107;

WHEREAS, the 2025 GRG 3/16 Capital Budget included line item (308K) for the Project;

**WHEREAS**, the 2026 GRG 3/16 Capital Budget will include line item 308K for the Project, subject to approval by the Board of Directors of the District (the "Board");

**WHEREAS**, pursuant to the District's Procurement Policy, the District issued and advertised a Request for Proposals for or in furtherance of the Project and received five (5) responses;

**WHEREAS**, Kozeny Wagner, Inc. was found to be qualified and whose proposal is in conformance with the requirements of the District Act (the "Proposal");

**WHEREAS**, the District desires to (i) authorize the Chief Executive Officer to approve and accept the Proposal; (ii) negotiate and enter into a contract with Kozeny Wagner, Inc.; and (iii) take any actions necessary or appropriate to effectuate the same; and

**WHEREAS**, at a meeting of the Board of Directors of the District (the "Board"), convened at 11:30 am, on November 12, 2025, at the District Offices at 3745 Foundry Way, St. Louis, Missouri, at which was present a quorum of the Board, the Board took the action further described herein.

## NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE METROPOLITAN PARK AND RECREATION DISTRICT D/B/A THE GREAT RIVERS GREENWAY DISTRICT AS FOLLOWS:

- 1. The Board authorizes the Chief Executive Officer to approve and accept the Proposal.
- 2. The Board authorizes the Chief Executive Officer to negotiate and enter into a contract with Kozeny Wagner, Inc. in an amount not to exceed \$75,430, subject to future appropriation for the Project.
- The Board authorizes the Chief Executive Officer or his designees to take such further action, and execute such other documents, certificates and instruments as may be necessary or desirable to carry out and comply with the intent of this Resolution.
- 4. All actions heretofore taken by the officers, agents, and employees of the District related to the transactions contemplated by this Resolution are hereby ratified and confirmed.
- 5. The portions of this Resolution shall be severable. In the event that any portion of this Resolution is found by a court of competent jurisdiction to be invalid, the remaining portions of this Resolution are valid, unless the court finds the valid portions of this Resolution are so essential and inseparably connected with and dependent upon the void portion that it cannot be presumed that the Board would have enacted the valid portions without the invalid ones, or unless the court finds that the valid portions standing alone are incomplete and are incapable of being executed in accordance with the legislative intent.
- 6. This Resolution shall be in full force and effect immediately from and after its adoption as provided by law.
