**WHEREAS,** the Metropolitan Park and Recreation District d/b/a The Great Rivers Greenway District (the "District") is a metropolitan park and recreation district authorized under Section 67.1700 to 67.1769 of the Revised Statutes of Missouri, as amended (the "District Act");

**WHEREAS,** pursuant to the Clean Water, Safe Parks, and Community Trails Initiative ("Proposition C"), the qualified voters of St. Louis County, St. Charles County, and St. Louis City approved the creation of the District;

**WHEREAS,** the District was formed to undertake the development, operation and maintenance of a public system of interconnecting trails and parks throughout the areas and counties comprising the District (the "District's Mission");

Staff issued an RFQ for Annual Audit Services in October 2023 for up to five (5) years beginning in calendar year 2024 for the 2023 fiscal year audit. In addition to our normal public advertising, the RFQ was sent directly to six (6) regional CPA firms who had responded to past GRG audit RFQ's. The RFQ was downloaded by four (4) of those firms. One of the direct solicitation firms and our current provider of accounting services, UHY Advisors MO, Inc., did not download the RFQ, but did email telling us they would not be submitting a response.

Therefore, we only received one (1) response, which was from Schmersahl Treloar & Co P.C., our current auditors.

The Board approved Resolution 2024.118 last year, which approved an update to the 2023-2025 Prequalification List for Planning, Landscape Architecture, Engineering, Architecture and Surveying services. #### **WHY AND/OR HOW:**

Great Rivers Greenway (GRG) owns and operates security cameras on the Mississippi, St. Vincent and Gravois Greenways at multiple locations including Kiener Plaza, Katherine Ward Burg Garden, Chain of Rocks Park, Muysun Charitable Trust Trailhead, the Riverfront Trail, Trojan Park and Ruth Porter Mall Park. There are also a series of access control gates and doors at Chain of Rocks Park to faciliate park opening and closing and support permitted bridge crossings. In addition, the Sustain team's operations facility has security cameras and access controls. Due to the complex nature of operating and maintaining a sophisticated security camera network, access controls, associated hardware, and a software license, GRG staff procured the services of a Utilitra LLC (Utilitra) for the 2026 calendar year. This procurement was for a one-year contract with the option for up to three (3) renewals through the end of 2029.

This annual service includes software license, diagnostic/troubleshooting issues, repair and replacement of hardware and additional unforeseen services to manage

the network. The contract includes a monthly fee for monitoring as well as additional funds for unforeseen issues that arise from equipment failure or network issues.

GRG staff request that Board authorize the CEO to negotiate and enter into a contract with Utilitra for \$47,000 for annual service, software license and as-needed services.

# WHY AND/OR HOW:

This action requests to approve a contract amendment with SWT Design, Inc. (SWT) to advance design from the Planning Stage to 30% Preliminary Design for the first phase of Shady Creek Greenway: Lorraine Davis Park to Larson Park in the City of Webster Groves.

#### **Project Background**

The Lorraine Davis Park to Larson Park segment of Shady Creek Greenway was first identified in Shady Creek and Deer Creek Greenways Concept Plan in 2006. The concept plan called for greenway connections in the cities of Webster Groves, Brentwood, Maplewood, and St. Louis. Since that time, Great Rivers Greenway has initiated and completed projects that have provided connections to Deer Creek Center, Deer Creek Park, Brentwood Park, Barnickle Park, and Lorraine Davis Park. The 2022 Regional Plan Update, and its planning process, also identified this area to connect neighboring communities and existing parks. The existing Deer Creek Greenway at Lorraine Davis Park terminates at East Ravine Ave, and this extension will improve regional connectivity, enhance recreational opportunities, and potentially address environmental goals such as streambank stabilization and improving water quality in Deer Creek.

This project is focused on extending the existing greenway from Lorraine Davis Park to Larson Park in Webster Groves. The initial phase of work is concentrated along Kirkham Avenue, between Gore and Elm Avenues (approximately .36 miles), which will align with and leverage construction related to the ongoing Metropolitan Sewer District (MSD) storm sewer project along Kirkham Avenue. Future phases of the project will extend beyond these limits to complete the connection between Lorraine Davis Park and Larson Park.

#### Details on this Action

This action intends to advance the preferred alignment of Shady Creek Greenway between Elm Ave and Gore Ave identified in the Planning Stage, which was completed in November 2025, to 30% Preliminary Design (labeled as "Shady Creek Greenway Phase 1 Project Limits" on the map below). Additionally, the team will explore alignment feasibility from the existing Deer Creek Greenway in Lorraine Davis Park to Elm Ave and from Gore Ave to Larson Park (labeled "Future Alignment Considerations" on the map below). SWT, with support from Intuition & Logic Engineering, Inc. and TREKK Design Group, LLC, will lead design services in conjunction with the community engagement consultant team. Their proposed scope

of work is expected to take approximately seven (7) months to complete and includes the following:

- 1. Survey Complete Topographic Survey, Utility Survey, and Boundary Survey between Elm Ave and Gore Ave.
- 2. Traffic Impact Study Evaluate anticipated traffic impacts associated with proposed lance modifications, intersection improvements, and potential signalization changes within the project corridor.
- 3. Utilities and Permitting Coordination Initiation of utility and regulatory coordination with key agencies such as St. Louis County, MSD, and the City of Webster Groves.
- 4. 30% Preliminary Design Plans Advance the preferred Elm Ave to Gore Ave alignment established during the Planning Phase to 30% Preliminary Design.
- 5. Discovery & Analysis Planning level discovery, analysis, and alignment feasibility for the two future Shady Creek Greenway segments, Lorraine Davis Park to Elm Ave and Gove Ave to Larson Park. Deliverables include mapping, feasibility summaries, a "pros and cons" matrix, and recommended alignments for each segment.

# **WHY AND/OR HOW:**

This action requests to authorize approval of a construction contract with Kozeny-Wagner, Inc. in an amount to to exceed \$292,211 in connection with St. Vincent Greenway: Signage Replacement from St. Vincent County Park to the North Hanley Metrolink Station.

#### PROJECT INFORMATION

This project will update the existing greenway wayfinding and interpretive signage on St. Vincent Greenway to the new Great Rivers Greenway ("GRG") signage standard and will make navigation clear for greenway users traveling between St. Vincent Park and the University of Missouri St. Louis ("UMSL") which is approximately 3.6 miles in total length.

GRG staff has worked with our partners at St. Louis County Parks & Recreation and UMSL to develop a wayfinding system that incorporates important destinations for greenway users. This project includes demolition of 35 existing signs, the installation of 24 new greenway signs, updated crosswalk painting at seven (7) intersections to increase greenway user safety, and the replacement of seven (7) bollards on UMSL's campus to control greenway access.

The project was advertised for bid in October 2025 and received two (2) bids. The bids received align with estimated construction costs and budget for the project. Bid results are shown below.

Kozeny-Wagner, Inc. \$265,654.27

Kendall, LLC \$282,452.00

GRG Staff and our design consultant, The Lamar Johnson Collaborative, Inc. ("LJC"), reviewed the bids received. Based on Kozeeny-Wagner's competitive bid, which is within budget and lower than the bid submitted by Kendall, LLC, and Kozeny-Wagner's positive working history with both GRG and LJC, GRG staff recommends awarding this construction contract to Kozeny-Wagner, Inc.

In addition to the bid, we are requesting 10% in contingency funds (\$26,575.73) for unforeseen circumstances. These funds will only be made available as needed through a written change order from the contractor and approved by GRG.

#### WHY AND/OR HOW:

This action requests to enter into a contract with McGrath & Associates, Inc. in an amount not to exceed \$219,445.60, which includes bid alternate 1 and 10% contingency, in connection with Sunset Greenway: Signage Replacement from Sunset Park to Coldwater Commons Park in Florissant, MO. This new project will update the existing greenway wayfinding and interpretive signage along the Sunset Greenway and a single sign in Truman Park, making navigation clear for users traveling between Sunset Park, through St. Ferdinand Park to Coldwater Commons Park which is approximately 4.5 miles in total length.

This project will upgrade signage to ensure an excellent wayfinding experience and consistent user experience where people have what locational information they need and can easily navigate and identify they are on a GRG greenway as part of the overall network. During design, we worked with the local agencies responsible for providing emergency response to confirm that the locator codes on our new signs will correspond with their 911 maps.

A total of 14 signs will be removed or relocated with a total of 22 new sign panels. This project will also improve crosswalk marking paint at the intersection of Mullanphy and Patterson for greenway users. St. Louis County does not have plans to improve this intersection for over a decade, so we determined that upgrading the marking paint as part of this project was beneficial for our user's safety.

Bid Alternate 1 includes the application of environmental graphics to three sides of a park building in St. Ferdinand Park. A metal building located in a highly visible spot for park users will be wrapped in vinyl graphics, calling attention to the Sunset Greenway connection and directing users to it.

McGrath & Associates, Inc. has successfully performed one signage replacement project for GRG (Western and Meramec Greenways, 2024) which was slightly larger. It is currently contracted for a signage replacement project on the Centennial Greenway. It produces quality work and is a good partner. There is about a 12-week lead on signs once the final proofs are approved, so removal and installation of signs will begin in earnest towards in late winter or early spring of 2026.

In an effort to improve Greenways and enhance user experience, Great Rivers

Greenway is seeking to supplement our conservation services with focused care on
several priority conservation sites throughout the District.

In 2025, Partnership for Youth, Inc. d/b/a AmeriCorps St. Louis ("AmeriCorps St. Louis") helped with conservation efforts along the Mississippi, River des Peres, St. Vincent, Fee Fee, Sunset, Dardenne, Busch, and Meramec Greenways. AmeriCorps members support Great Rivers Greenway Conservation and Operations staff by removing invasive bush honeysuckle, felling invasive callery pear trees, sealing cracks along the Busch Greenway, working in rain gardens, painting benches at Kiener, planting trees with Forest ReLeaf and more. ## **WHY AND/OR HOW:**

After a successful partnership in 2025, the District would like to continue our support for the Missouri Botanical Garden's Outdoor Leadership Corps (OLC) program. This program facilitates conservation stewardship projects, leadership trainings, handson skill building opportunities, and "green" career exploration through paid work experience along the greenways. We intend to host two (2) seasonal cohorts in 2026, one late January - April and another September - December. At the close of each season, participants will have gained the knowledge and skills to pursue entry-level, full-time employment in parks maintenance, conservation, and horticulture.

A crew of four (4) program participants and one (1) crew leader will assist in invasive species management, native planting, landscape bed maintenance, and greenway clean-up projects over approximately eighty (80) days of service in 2026. The crew will focus their efforts at selected service sites on the Mississippi, Fee Fee, Busch, Shady Creek, St. Vincent, Sunset, Dardenne, Gravois, and Western Greenways in St. Louis City, St. Louis County and St. Charles County.

2026 will be our fourth full year partnering with Missouri Botanical Garden on the Outdoor Leadership Corps program. In 2025, program participants served for 498 hours at 17 Great Rivers Greenway sites, worked along 9 different Greenways, managed 1.5 acres of invasive plants, planted 135 native plants and trees, collected 2.42 cubic yards of trash, and assisted with 5 operations projects including bench painting and landscaping at Kiener Plaza, and tree pruning Leonor K. Sullivan Blvd.

Program participants attended training sessions hosted by Great Rivers Greenway, Missouri Botanical Garden, Forest ReLeaf of Missouri, Litzsinger Road Ecology Center, Shaw Nature Reserve, and the Missouri Department of Conservation. Three Restoration Assistants plan to return to the program in 2026, with two being

interested in the Assistant Crew Leader position. The other members are currently looking for jobs in the horticulture and ecological restoration fields. Great Rivers Greenway staff were extremely pleased with the outcome of last year's program. In 2026, we hope to build on that success.

District staff are requesting that the Board of Directors authorize the CEO to negotiate and enter into a contract with Missouri Botanical Garden for the Outdoor Leadership Program. The total anticipated cost of the OLC program in 2026 is \$115,969.

#### WHY AND/OR HOW:

This action is to approve a contract amendment with Civil Design, Inc. (CDI) for \$167,280 for Project Control Consulting Services for 2026. This is the second year of a three (3) year annual contract through December, 2027.

Starting in 2015, GRG initiated a process to develop a Project Controls System (PCS) used by the Build Team, and more recently the Sustain Team, for planning and delivering GRG's Capital Improvement Program. The PCS consists of internal business processes, a configurable on-premises project controls software program (InScope), and regularly scheduled weekly and bi-monthly project check-in meetings to monitor project risks, schedule updates and costs, among other updates. GRG staff have embraced a culture and practice that has assisted the team in carrying out their Project Management duties as projects have become more complex and project tracking and reporting is critical. An important component of the PCS has been the consultant team that works with GRG staff in the form of a Project Management Office. This service works with staff to enhance the project delivery and efficiency on individual greenway projects while continuing to support the advancement and monitoring of the overall Capital Improvement Program.

GRG issued a Request for Qualifications (RFQ) for Project Controls Consulting Services last year and the GRG Board approved Resolution 2024.112 which authorized a contract with CDI for 2025 services. Kevin Corwin serves as the Project Leader of the Project Management Office and has a vast knowledge of GRG's procedures, policies and the InScope system. For the 2026 scope of work, GRG staff has coordinated with CDI for two (2) additional services for this year beyond the typical

annual scope of work. The first item is to have Kevin work with the GRG team on the In-House Construction Management that is contemplated. Kevin will assist with the operational and financial analysis for the In-house Construction Management, assist staff with establishing operational duties, activities and standards and assist in organizing and orientation for new staff associated with Construction Management duties.

The second new task for this year will be to assist staff on the new Project Controls software program. This will be a time-intensive activity which will include Kevin being part of the GRG team scoping and developing the contract GRG will have with the selected new software. And with Kevin's extensive knowledge on the previous software programs, he will be critical in participating in the customization of the selected software based on GRG's project delivery and expectations. Additionally, the CDI team will be used for software integrations into GRG's other platforms such as Geographic Information System (GIS), Abila and CMx (the Contract Management System) which will be more efficient and less costly than having a new firm unfamiliar with our platforms perform the integrations.

The scope and fee for 2026 is \$167,280 which is higher than the 2025 cost of services which was \$129,950. Staff reviewed the tasks associated with the new tasks for 2026 and are recommending this increased fee. The 2026 budget is \$350,000 which leave sufficient budget for other contracts next year. It is anticipated that the new Project Control Software contract will be brought to the Board in April or May next year. Staff recommends approval of the contract amendment with Civil Design, Inc.

#### WHY AND/OR HOW:

This action requests an amendment to the 2022 Intergovernmental Cooperation Agreement between Great Rivers Greenway (GRG) and the City of O'Fallon to provide \$275,000 to provide greenway amenities for the Twin Islands Trailhead at Technology Drive, I-64 and Dardenne Creek for the 2026 and 2027 Capital Budgets.

#### **Background**

The St. Charles County Greenway Master Plan, adopted by GRG Board Resolution 2021.02, was an outcome of an 18-month community engagement process that outlined nine priority greenway projects. These planned corridors generally fall within three categories: 1. Completion of the Dardenne Greenway as the "backbone" of greenways in St. Charles County; 2. Creation of links between Dardenne Greenway and the Katy Trail State Park; and 3. Extension of future greenways west toward high growth areas such as Lake St. Louis and Wentzville. These nine recommendations were established through extensive public input and reflect county residents' most desired greenway projects that Great Rivers Greenway and partner municipalities should focus on in coming years.

Currently, Dardenne Greenway's westernmost point is BaratHaven near Technology Drive and I-64, adjacent to St. Charles Community College's Dardenne Creek Campus. This strategic location may eventually branch west along Dardenne Creek toward Broemmelsiek County Park and south, through Busch Conservation Area as an extension of Busch Greenway to the Katy Trail. User groups have indicated that this location would be ideal for developing a trailhead, with parking and other greenway and trail amenities.

As a municipal partner on the county-wide greenway plan, the City of O'Fallon approached GRG with the opportunity to partner on the design of the trailhead. O'Fallon was awarded a \$660,000 TAP grant for the design and construction of bicycle and pedestrian facilities for this trailhead which would include trailhead

parking, a bicycle and pedestrian bridge over Dardenne Creek and trail connections to the existing Dardenne Greenway and City of O'Fallon trails.

#### **Details on this Action**

In 2022, GRG entered into a cooperation agreement with O'Fallon to provide \$50,000 to support the city's local match for design services. The design team is being led by CDG Engineers, Inc. with subconsultants Planning Design Studio LLC (landscape architecture), Millenia Professional Services (survey and geotechnical), and David Mason & Associates, Inc. (utilities).

The project consists of two major components:

Replacement of the Technology Drive bridge over Dardenne Creek: Early in the design process, the Missouri Department of Transportation (MoDOT) determined that the existing Technology Drive bridge was functionally obsolete and its elevation interfered with the floodway of Dardenne Creek. This created a beneficial opportunity for the Dardenne Greenway trailhead project in that MoDOT agreed to replace the vehicular bridge to current standards with striped bicycle lanes, in both north and southbound directions, as well as a barrier separated shared use path with connections to the planned trailhead. Dardenne Greenway branding will be added to the under sides of the new Technology Drive bridge and the existing I-64 bridges over Dardenne Creek and MoDOT has provided all necessary easements for the trail to extend beneath I-64.

Construction of the Twin Islands Trailhead: Utilizing TAP funding and supplemental support from GRG, the new trailhead will include vehicular parking and connections to existing trails such as the western end of Dardenne Greenway. GRG's \$275,000 contribution to the project will be used for additional landscaping, GRG signage and branding and other amenities for trail users.

MoDOT started construction of the Technology Drive bridge in August 2025, and O'Fallon will lead the trailhead construction in spring 2026. The amended agreement with O'Fallon will also incorporate obligations for the operation and maintenance of greenway facilities. GRG has included funding with the 2026 Capital Budget for a portion of the funds with the balance included in the 2027 Capital Budget. Invoices from O'Fallon will remain within the available budget for each year.

#### **Background**

#### WHY AND/OR HOW:

This action authorizes Great Rivers Greenway (GRG) to enter into a Contract
Amendment with SmithGroup, Inc. (SmithGroup) for \$558,000 to provide design
services for the Brickline Greenway segment along the Gateway Mall in Downtown St.
Louis, from 20th Street to Gateway Arch National Park, and to assist GRG with two
federal grant applications.

#### **Background**

In 2019, GRG's Board of Directors adopted the Brickline Greenway Framework Plan, which identified numerous alignments that will eventually connect Forest Park, Gateway Arch National Park, Fairground Park and Tower Grove Park in the City of St. Louis. Progress toward implementing each of these greenway segments is proceeding at separate paces, reflecting available funding, partnerships and capacity. The latest segment that Great Rivers Greenway is undertaking is along the Gateway Mall, between 20th and 4th Streets in Downtown St. Louis.

This Brickline Greenway segment will be located on the north side of Market street, following the alignment and design character of the existing Brickline Greenway at Energizer Park Stadium between 20<sup>th</sup> and 22<sup>nd</sup> Streets. Design guidelines have been created specifically for the Brickline Greenway, and design consultants for this effort will follow these standards to ensure consistency with other Brickline segments. However, there may be conditions along the Gateway Mall where the existing landscape may not readily facilitate the standard Brickline Greenway design. Adjacent landscape areas and uses within the Gateway Mall are currently under study by Greater St. Louis, Inc., and coordination between the design teams is critical for a seamless experience along these multiple city blocks and various park and civic landscapes.

#### **Details on this Action**

GRG staff and a selection committee of project stakeholders recommended the SmithGroup team in August 2024 to be the lead designer for this project, with community engagement support from Vector Communications. Since late 2024, the SmithGroup design team has made steady progress planning Brickline Greenway along the 16 blocks of the Gateway Mall, from the Arch to 20th Street. Coordination with the City of St. Louis, and various property owners and institutions along Market Street and others has been underway since 2024 which has been supportive of the design discussions to date.

Through the design process, GRG staff are making three (3) significant recommendations to the Brickline Gateway Mall project going forward:

First, that the project be divided into two phases. Phase 1 (east) extends between 4th Street and Tucker Blvd; Phase 2 (west) is between Tucker and 20th Street at Energizer Park, across from Union Station. This will allow us to phase the future construction in a manageable manner and allow us to more easily seek Federal Transportation grants.

Second, that the project should also incorporate a new streetscape on the south side of Market Street. While this expands the overall project scope and budget, it makes the project eligible--and competitive--for certain Federal Transportation grants if traffic improvements are completed as part of the work to be done. By including the south side of Market, this also solves several important logistical construction challenges such as regrading and resurfacing the crown of Market Street for stormwater draining, improves traffic calming and pedestrian safety, and incorporates Intelligent Traffic Systems (ITS) technology to automate and improve traffic flow, particularly after special events downtown. ITS is an important component of the overall project succeeding with major events downtown like St. Louis Blues games, events at hotels and Stifel Theatre, etc.

Third, that GRG will seek two Congestion Mitigation and Air Quality (CMAQ) grants to leverage private funding already committed to the project. Applications for the current round of CMAQ funding are due in February 2026, and the next round is expected the following February. Staff will submit a CMAQ application for GRG Board approval at the January 2026 Board meeting for Phase I.

SmithGroup's proposed timeline for completing the various deliverables under this Contract Amendment are as follows:

The proposed scope of work includes two (2) CMAQ grant applications, as well as design services for the streetscape on the south side of Market Street, and incudes geotechnical work, ground penetrating radar pavement boring and cores. SmithGroup will also provide updated renderings and will facilitate additional stakeholder meetings for project coordination. Additional fees requested for this proposal will not exceed \$558.000. Funds for this contract will be from private sources funded through the GRG Foundation.

#### PROCUREMENT RESULTS DETAIL (BID RESULTS, SUMMARY OF INTERVIEWS, ETC)

In October 2025, Great Rivers Greenway (GRG) staff released a Request for Qualifications (RFQ) for pre-construction and construction management services across multiple greenway projects including three (3) separate projects, including: Maline Greenway: West Florissant to Nolte (296), Maline Greenway: Nolte to Bella Fontaine Park West (296A), and Hodiamont Greenway: Goodfellow to Belt Ave (288A).

The RFQ was published in the St. Louis Post-Dispatch, the St. Louis American newspapers, the GRG website, and was announced via an email to GRG's jobs and bids electronic database. Five (5) responses were received that expressed interest in

the services for the advertised Hodiamont & Maline projects (288A, 296, 296A). A selection committee composed of GRG staff evaluated the proposals. All five (5) firms that applied for the Hodiamont & Maline projects (288A, 296, 296A) were interviewed in November. The selection committee unanimously recommended Navigate Building Solutions, LLC as the best qualified and capable firm to perform the services outlined in the RFQ for the Maline Greenway project (296).

#### **WHY AND/OR HOW:**

This action is to approve a contract with Navigate Building Solutions, LLC for preconstruction management services of the Maline Greenway segment from West Florissant Avenue to Nolte Avenue, for a sum not to exceed \$43,403. Funding for the services includes budgeted funds in the current 2026 GRG 3/16 Capital Budget.

#### **General Information**

In 2010 - 2011, Great Rivers Greenway ("GRG") worked in partnership with its consultant, Woolpert, Inc., and various municipalities of north St. Louis County to study the Maline Creek corridor. The study area covered a 1-mile wide area (1/2-mile on each side of the creek) and ran through portions of the cities of Berkeley, Kinloch, Ferguson, Jennings, Moline Acres, Bellefontaine Neighbors, Riverview, and St. Louis, as well as unincorporated St. Louis County. GRG staff worked with a Citizen Advisory Committee and a Technical Advisory Committee to develop the 2011 Maline Greenway Concept Plan, which now serves as the master planning document that identifies the general alignment for the 8-mile long Maline Greenway.

The completed portion of the Maline Greenway trail runs 2.12 miles from St. Louis County's Bella Fontaine Park West, eastward through Bella Fontaine Park, and ends at St. Cyr Road near where Maline Creek crosses from Bellefontaine Neighbors into the City of St. Louis. In 2025, GRG will begin constructing a separate 1.6-mile segment between the Ted Jones Trail and West Florissant Avenue in the City of Ferguson.

Between these two (2) sections of trail is an approximately 2-mile gap between the City of Ferguson and unincorporated St. Louis County. That gap constitutes project (296) Maline Greenway: West Florissant Avenue to Bella Fontaine Park West.

#### Project Background

The 2011 Maline Greenway Concept Plan identified a creek-side alignment that would cover this 2-mile gap. Due to severe site constraints such as flooding, floodplain permitting, and environmental safety concerns, an alternative alignment was also identified for planning phase analysis. In August 2022, GRG staff procured a consultant team led by Lochmueller Group and Vector Communications Corporation to begin the process of exploring and analyzing greenway route options along the two (2) main corridors under consideration. The feasibility study process weaved together technical analysis and evaluation with community engagement and input at every step along the way. The team collaborated heavily with St. Louis County and the cities of Ferguson and Jennings, local schools, and the local police departments. Most importantly, a Community Advisory Committee comprised of elected officials, residents, and regional stakeholders helped guide the collection

of data and analyze results to ultimately generate a recommended final alignment to be developed further in the design phase.

The Study evaluated potential greenway alignments, trailhead configurations, neighborhood connections, crossing strategies, and integration opportunities with adjacent development projects. Community feedback, risk assessments, cost estimates, utility coordination, environmental impact, and experiential factors were weighed in determining the final recommended greenway alignment (see the map graphic). This provides opportunities for the greenway to create a unique linear park experience for users while directly connecting to seven (7) residential streets in the neighborhood west of Halls Ferry Road. GRG's Planning Committee approved the recommended alignment in November 2023.

The Lochmeuller Team completed 30% design for the Trail segment in late 2024. As part of that phase of work, the team evaluated how to make a connection over Halls Ferry Road, which is a busy arterial corridor controlled by the Missouri Department of Transportation. Additionally, the connection from Halls Ferry into Bella Fontaine Park West requires a bridge connection over Maline Creek. The map below identifies that area from Halls Ferry to the Park with the dotted lines. After careful review and coordination with GRG and partners, the Team recommended bridges that would cross over Halls Ferry Road and Maline Creek into the Park. During 2024, while the trail was designed to 30%, the bridges were not designed beyond conceptual design in order to determine feasibility. This phase of work will proceed under the project 296A Nolte Avenue to Bella Fontaine Park West. This Board action is to contract for pre-construction services for portion the segment from West Florissant Avenue to Nolte Avenue.

Navigate Building Solutions, LLC will work on the following pre-construction management tasks:

- Constructability review of the Design team's drawings and specifications
- Preliminary evaluation of GRG scope, schedule, and budget
- Provide construction cost estimates based off to the 95%-100% design set
- Provide guidance and recommendations for quality, cost or schedule
- Provide guidance and recommendations for safety, division of responsibilities, risk, and material acquisition

- Assist the design team in the development of bidding documents and bidding process through preparation, evaluation, selection, and contract execution
- Obtain various regulatory or special permits

The Navigate Building Solutions, LLC team was procured following an open request for qualifications detailed above.

The not-to-exceed fee is established at \$43,403 for the contract. The 2025 budget for the (296) project included \$113,000 and is carried over into the 2026 Capital Budget. It is anticipated that a construction management contract amendment will be brought to the Board for consideration later in 2026 when the project is ready for public bidding.

#### PROCUREMENT RESULTS DETAIL (BID RESULTS, SUMMARY OF INTERVIEWS, ETC)

In August 2023, Great Rivers Greenway (GRG) solicited qualifications for civic engagement services and received submittals from fourteen (14) firms including Vector Communications Corporation (Vector). Staff interviewed all firms and reviewed all submittals, and selected Vector to be included on the 2024-2026 Civic Engagement Vendors List.

In September 2025, GRG solicited invitations to interview for civic engagement services for multiple greenway planning and design projects with services anticipated to begin in 2026. Three firms, each from the existing 2024-2026 Civic Engagement Vendors List, were invited to interview for four (4) projects. Interviews were conducted in October 2025. Following interviews, staff selected Vector Communications Corporation for civic engagement services for Brickline Greenway due to their extensive experience with engagement service for this project and for other large scale GRG projects in the St. Louis region including the 2013 CityArchRiver design competition, the 2020 Regional Plan, other greenway projects including Hodiamont Greenway and Maline Greenway, and Vector's ongoing engagement support for the Brickline Greenway project since 2017. Under this new contract, Vector will continue to support the ongoing engagement for all segments of the Brickline Greenway during the project's planning, design and construction efforts.

#### WHY AND/OR HOW:

This Board Action is to approve a new contract in the amount of \$100,000 forwith Vector Communications Corporation (Vector) for professional civic engagement services and supports related to the planning, design and construction for all segments of the Brickline Greenway.

#### Background

Engagement for the Brickline Greenway has been ongoing since 2018 to build awareness of the project locally and regionally, to maximize opportunities for community involvement and participation in planning and design efforts, to establish new and maintain existing community relationships, and to ensure meaningful community participation through inclusive and collaborative engagement processes. Engagement for this project has included segment and neighborhood specific engagement; adjacent stakeholder engagement with residents, property owners and business owners; advisory and working group engagement; and general engagement planning, project management and execution. This work has been and is currently being supported by Vector, and led by the Great Rivers Greenway (GRG) engagement and project staff since 2018.

#### **Details on this Action**

This contract requests a new scope of services and related fees to ensure relevant engagement supports for the Brickline Greenway. GRG staff requests authorization to enter into a \$100,000 contract for professional services to be performed by Vector for civic engagement to support all active segments of the Brickline Greenway currently in planning, design and construction.

With this new contract, Vector will continue to coordinate with GRG staff, planning and design consultants, other vendors and partners to provide professional engagement services including neighborhood outreach and canvassing; event logistics and management; meeting scheduling and facilitation; documentation of meetings, activities and events; coordination of advisory and working groups; preparing, gathering, analyzing and reporting of data collected for quantitative and qualitative inputs; and generally supporting efforts to keep the local, regional and community-at-large informed about the Brickline Greenway. This work will allow GRG, with Vector's support, to invite and include public input on planning and design for the Brickline Greenway, and willto ensure that the design of all segments of the Brickline Greenway, including any related signature projects included in segment design, are informed by community input. It will also allow for appropriate levels of engagement and community awareness around projects nearing or in construction.

This contract is anticipated to continue services through the end of 2026. A new engagement contract will be considered for planning, design and construction engagement beyond 2026, and will be brought to the GRG Board for consideration.

#### WHY AND/OR HOW:

Starting in September 2019, Great Rivers Greenway (GRG) staff began contracting with Cannonball, Inc. to have a staff member embedded into the team for communications for Brickline Greenway. To ensure that this project gets the focus and attention it deserves while also allowing Team Promote staff to serve all other projects in the region, staff recommends having Cannonball, Inc. continue to serve as the Communications Director for the project. The setup has gone very well, bringing extra capacity to both the project and GRG overall. The Brickline Greenway project has its own set of opportunities, challenges, stakeholders and even brand platform, requiring more communications work than most projects. Our project manager has been consistent this whole time, knows the project very well, attends weekly meetings and leads the day to day efforts with Emma's support. With Brickline Greenway continuing to grow in complexity and staff needs, having this consistent presence who can act as a Communications staff member has been very valuable to the team.

The scope of work includes 4 primary responsibilities:

- Maintain an awareness and understanding of the project and process by participating in project meetings and communications (extension of staff team).
- 2. Serve as Communications Coordinator by setting and adjusting the strategy for overall communications:
  - Lead on and make recommendations for all general regional communications including, but not limited to, website, email newsletter, social media, handouts, presentations and advertising.
  - 2. Support civic engagement work such as supplying messaging and/or graphics or materials to convey key concepts through handouts, web content, emails and presentations.
  - 3. Monitor for social media mentions and ensure brand and message consistency.
  - 4. Coordinate with partners, donors and other stakeholders as directed by staff in the above processes (i.e., getting buy-in or approvals for major announcements, etc.).
- 3. Coordinate with the design teams and others to ensure the brand is integrated throughout the design, coordinating on wayfinding and interpretive signage, programs and environmental graphics.
- 4. Coordinate with GRG Foundation staff and any key stakeholders to support overall development and fundraising program. This includes but is not limited to:
  - 1. Creation of, editing of or brand review of message platforms or case statements and all associated materials.
  - 2. Supporting meetings and events with direction of messaging, speeches, materials, invitations, etc.

After asking 3 of those firms to respond to a request for a relationship like this with an embedded consultant, Cannonball, Inc. was recommended to complete the scope of work. Their current and former clients are relevant to our goals, including the recent

STLMade movement to boost St. Louis as a city and region both internally and externally. Cannonball, Inc. does work locally and nationally for brands like Enterprise, Budweiser, Saint Louis Art Museum, COCA, Bellefontaine Cemetery, Busch Gardens, the Pulitzer Arts Foundation and many more. They are 50% womenowned, but not a DBE or MBE firm. We do not currently have any planned projects for them that include sub-consultants, those needs arise with any given project need.

#### WHY AND/OR HOW:

This action requests to authorize the CEO to enter into a reimbursement agreement with St. Louis County in the amount of \$1,321,579 for local matching funds for the 2023 Surface Transportation Program - (STP-S) for the Schuetz Road Improvement Project. TIn 2023, the GRG Board approved the partnership with St. Louis County in 2023, whose application was selected by East-West Gateway Council of Governments for the STP-S funding. This project on Schuetz Road was identified in the Centennial Greenway Master Plan and provides an opportunity to leverage federal transportation funds with St. Louis County.

St. Louis County's Schuetz Road Improvement Project proposes to resurface the road, add ADA curb ramps at side streets, install ADA-compliant pedestrian push buttons and signal heads, improve drainage and water quality and add a 10-foot wide shared-use path (Centennial Greenway) on one side of the street. Physically, the topography and land use would allow for increased green space in several locations along the proposed side path.

The Centennial Greenway alignment in this area is proposed along Schuetz Road per the Centennial Greenway Master Plan from 2006. It is also part of the St. Louis County Action Plan for Walking & Biking, which had community feedback in support of this alignment in 2020. This is a residential area, and the project will impact residential driveways, as well as one church, a firehouse, an elementary school and community center. Because GRG's Centennial Greenway: U.S. 67 to Gandy Drive project has identified a Schuetz Rd alignment to GRG's project scope, the local match dollars would be allocated toward construction of a 1.1 mile long, 10 foot wide shared-use path running along one side of Schuetz Rd. This east-west path would enhance the Centennial Greenway by safely transporting bicyclists and pedestrians between U.S. 67 and Gandy Drive, and in the future will connect to the Centennial Greenway currently under construction in Olivette (to the east) and to the Creve Coeur Lake Memorial Park and the Katy Trail and the Centennial Greenway in St. Charles (to the west).

St. Louis County obtained an STP-S from East-West Gateway for the Design Services, Right-of-Way purchasing and Construction. The current total project cost estimate is

\$7,600,000. The project is currently in design and GRG staff have been participating in coordination meetings with St. Louis County. The project is anticipated to be completed in 2028. Below is the financial plan for the future years which shows the GRG share for the various phases of work:

GRG staff supports the County's efforts in leveraging federal transportation funds to construct an important greenway connection from U.S. 67 to Gandy Drive and supports GRG's efforts to make regional connections in St. Louis County. This action requests to authorize the CEO to enter into a reimbursement agreement with St. Louis County in the amount of \$1,284,586 for local matching funds for the 2023 Surface Transportation Program - (STP-S) for the Vernon Avenue Improvement Project in the City of University City. In 2023, tThe GRG Board approved the partnership with St. Louis County, in 2023 whose application was selected by East-West Gateway Council of Governments for the STP-S. This project on Vernon Avenue was identified in the Centennial Greenway Master Plan and provides an opportunity to leverage federal transportation funds with St. Louis County.

St. Louis County's Vernon Road Improvement Project proposes to resurface the road, add ADA curb ramps at side streets, install ADA-compliant pedestrian push buttons and signal heads at Kingsland Ave, improve drainage and water quality and add a 10 foot wide shared-use path (Centennial Greenway) on the north side of the street. There will be a need to (1) relocate a large portion of the northern curb and repurpose that space within the existing right of way and (2) narrow traffic lanes as much as possible to build the greenway. This project would connect two segments of the Centennial Greenway in University City.

The Centennial Greenway alignment in this area is proposed along Vernon Avenue per the Centennial Greenway Master Plan from 2006. It is also part of the St. Louis County Action Plan for Walking & Biking, which had community feedback in support of this alignment in 2020. There will be a need to increase the civic engagement efforts to communicate specific project elements with the community during the planning phase. This is a dense residential area, impacting driveways, one church and a firehouse. Because GRG's Centennial Greenway project has identified a Vernon Avenue alignment as GRG's project scope, the local match dollars would be allocated toward construction of a 1 mile long, 10 foot wide shared-use path running along the north side of Vernon Ave.

This proposed 1 mile east-west path would construct the Centennial Greenway along Vernon Avenue and safely transport greenway users between the existing Ackert Walkway/Centennial Greenway and Vernon Ave intersection, to University City's Heman Park trail system and a small segment of the Centennial Greenway built by University City many years ago. By working with St. Louis County and University City, the Greenway would extend from the existing greenway as it travels from Forest Park, through Washington University, Delmar Loop, Ackert Walkway and connecting to Heman Park, a distance of 2.3 miles.

The current project cost estimate is \$7,300,000. The project is currently in design and GRG staff have participated in coordination meetings with the County and University City. The construction is anticipated to be completed in 2028. Below is the financial plan proposed to be completed with GRG's share identified:

# **WHY AND/OR HOW:**

This action is to accept a Congestion Mitigation and Air Quality (CMAQ) project program agreement providing for an anticipated amount of \$6,000,000, or such greater or lesser amount as may be available, with the Missouri Highways and Transportation Commission in connection with the Brickline Greenway: Boyle-Clayton to Forest Park segment.

The segment starting at the Cortex MetroLink Station at Boyle Avenue and connecting to the intersection of Clayton/Boyle Avenues and Forest Park along Clayton Avenue is a vital and complex section of the Brickline Greenway (see map below). It involves partnering with several major health institutions including Washington University Medical Center (WUMC), Barnes Jewish-Christian Health Services (BJC) and Shriners Hospital for planning and right of way access. In addition, the intersection of Clayton/Boyle is a key component of the future I-64 project to reduce traffic and congestion on Interstate 64. GRG has been working hand in hand with the Missouri Department of Transportation (MoDOT) and the City of St. Louis to ensure this greenway project dovetails with the future Interstate 64 improvements to improve traffic flow for motorists, pedestrians and cyclists.

Several potential connections to Forest Park were considered during the Brickline Greenway Framework Plan process. In cooperation with the aforementioned healthcare institutions, alternative alignments were evaluated in 2022 with a conclusion that Clayton Avenue was the most feasible and direct route to connect the existing segment of Brickline Greenway at Cortex MetroLink Station to Forest Park, utilizing the Kingshighway underpass to reach the park.

Washington University Medical Center provided \$335,000 to the GRG Foundation to fund Schematic design of the alignment working in partnership with the various institutions. GRG contracted with Lamar Johnson Collaborative, LLC (LJC) to plan, design, and deliver construction documentation for this approximately one-mile section of the Brickline Greenway. The Schematic Design completed in July of 2024 and includes 30 percent designs involving:

- Collaborating with GRG and WUMC to review current design standards and coordinate design of new streetscape elements related to Brickline Greenway
- Partnering with Lochmueller Group (Lochmueller) to determine roadway impacts of various transportation projects
- Partnering with David Mason and Associates (DMA) to provide survey data
- Supporting engagement with community, stakeholder and technical advisory groups
- Following Brickline Design Guidelines to identify greenway features such as paying, lighting, wayfinding signage, landscape, exterior furnishings, crosswalks and other amenities

Providing an updated construction cost estimate.

In November 2024, GRG contracted with Lochmueller Group to develop a CMAQ application for this section of the greenway. The Board authorized Resolution 2025.15 to apply for funding for this project under the CMAQ grant program through the East-West Gateway Council of Governments. The program is administered by the Federal Highway Administration (FHWA) through the MoDOT and provides funding utilized by states and localities for transportation improvement projects. Projects may leverage a maximum of 80% of federal funds and require a minimum 20% local match. Projects which include greater than 20% local matching funds typically score higher in the review process. Projects that are selected by East-West Gateway Council of Governments would be eligible for construction activities starting in FHWA fiscal year 2028 (October 2027). The application was approved and in August, GRG received notice of award of \$6,000,000 in CMAQ funding for the project.

The total project is estimated to be \$16.6 million which includes greenway and roadway improvements. GRG is responsible for the remainder of the project costs not supplied by the Grant funds (currently estimated to be \$10 million). GRG has received private donation pledges in the amount of \$10 million from local entities. These donations represent the funding that will need to be allocated in GRG's future budgets to ensure GRG meets its local matching requirements under the CMAQ Grant. These private donations are representative of the extensive support GRG has developed within the local community for this project. Approval of this action allows GRG to administer the CMAQ project and enter into the necessary grant agreements with MoDOT.

**WHEREAS,** in furtherance of the District's Mission, and in accordance with the Bylaws of the District, the District adopted "Building the River Ring" as the Regional Plan for the District, and which contains the comprehensive plan of the District, its existing and proposed interconnecting greenway, park and trail projects, and any proposed land acquisitions (the "River Ring Regional Plan");

**WHEREAS,** the Brickline Greenway is shown as a regional greenway in the River Ring Regional Plan (the "Brickline Greenway");

**WHEREAS,** the District desires to extend and improve the River Ring in furtherance of the River Ring Regional Plan by planning, designing and constructing the Brickline Greenway: Boyle-Clayton to Forest Park (the "Project");

**WHEREAS,** pursuant to the approval of the Safe and Accessible Arch and Public Parks Initiative ("Proposition P") and Section 67.1712.2 of the District Act, the governing bodies of St. Louis City and St. Louis County imposed a three-sixteenths of one cent sales tax for the purpose of funding the operation and maintenance of the portion of the District located within St. Louis City and St. Louis County;

**WHEREAS,** the 2026 GRG 3/16 Capital Budget was approved by the District pursuant to Resolution 2025.136;

WHEREAS, the 2026 GRG 3/16 Capital Budget included line item 308P for the Project;

**WHEREAS,** the District desires to authorize the Chief Executive Officer to (i) negotiate and enter into a Program agreement with The Missouri Highways and Transportation Commission; and (ii) take any actions necessary or appropriate to effectuate the same; and

**WHEREAS,** at a meeting of the Board of Directors of the District (the "Board"), convened at 11:30 am, on December 9, 2025 at the District Offices at 3745 Foundry Way, St. Louis, Missouri, at which was present a quorum of the Board, the Board took the action further described herein.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE METROPOLITAN PARK AND RECREATION DISTRICT D/B/A THE GREAT RIVERS GREENWAY DISTRICT AS FOLLOWS:

- The Board authorizes the Chief Executive Officer to negotiate and enter into a
  Congestion Mitigation and Air Quality Program Agreement and a Grant
  Agreement with the Missouri Highways and Transportation
  Commission providing for an anticipated amount of \$6,000,000, or such greater or
  lesser amount as may be available, in grant funding under the Congestion Mitigation
  and Air Quality Program for the Project.
- The Board authorizes the Chief Executive Officer or his designees to take such further action, and execute such other documents, certificates and instruments as may be necessary or desirable to carry out and comply with the intent of this Resolution.
- 3. All actions heretofore taken by the officers, agents, and employees of the District related to the transactions contemplated by this Resolution are hereby ratified and confirmed.
- 4. The portions of this Resolution shall be severable. In the event that any portion of this Resolution is found by a court of competent jurisdiction to be invalid, the remaining portions of this Resolution are valid, unless the court finds the valid portions of this Resolution are so essential and inseparably connected with and dependent upon the void portion that it cannot be presumed that the Board would have enacted the valid portions without the invalid ones, or unless the court finds that the valid portions standing alone are incomplete and are incapable of being executed in accordance with the legislative intent.
- 5. This Resolution shall be in full force and effect immediately from and after its adoption as provided by law.
